SOLICITATION AMENDMENT N° 4

PLEASE NOTE THAT THIS IS THE LAST AMENDMENT TO ANSWER QUESTION UNDER SOLICITATION EN578-055605/F PERIOD 1

B: QUESTIONS AND ANSWERS

B: This amendment is raised to answer the following questions:

Q 40:

(i) Are there specific instructions for new jv submissions? If so, could I be directed to them please.

(ii) Is there a possibility of an information session to provide orientation to suppliers on how to submit a joint venture proposal on TBIPS?

A 40:

(i) Please refer to Attachment C and to Attachment H article 16.

(ii) We are unable to accommodate this request.

Q 41:

We previously submitted for TBIPS and did not qualify, mainly due to price I believe.

We understand that perhaps this is no longer an obstacle under new TBIPS. As such, large companies like ours may have an opportunity to now qualify. If that is the case, we are not clear on the process resubmit.

We have reviewed the attached RFP. Is the next deadline for submission end of March 2014? Is there another submission period ending June 2014? Is there someone we talk to in order to be very clear on the process/opportunity?

A 41:

Please refer to Solicitation Amendment 003, A18 (ii).

Q 42:

We would like to apply for the new categories for Stream 5, Project Management Services, P.13 and P.14. Our firm already qualifies for ten (10) of the categories in this Steam as Currently Substantiated. Using the 50% rule, can we apply for the two new categories as Newly unsubstantiated?

A 42:

Newly Unsubstantiated categories can only be awarded against Newly Substantiated Categories from this bid process. Unsubstantiated categories cannot be awarded using categories that received a positive reference from a previous bid process. Please refer to Attachment C, M5 article 7 (iii).

Q 43:

Question for current refresh closing March 31st, 2014.

We submitted for Tier 1 and Tier 2, but due to an issue with our insurance, we were not granted Tier 2.

We would like to reapply for Tier 2. What is required? Do I provide grandfather certification, so Tier 1 information is transferred over to Tier 2 authomatically? So all I need to apply for Tier 2 is to provide grandfather certification and provide proof of insurance certificate? Please advise.

Q 44:

If a company was qualified for the Tier 1 and Tier 2 in the last submission, but did not qualify for 2 categories in the Cyber Protection stream, do we just grandfather everything and input into CPSS the references to the categories that we did not meet.

You would fall under Column D in the Submission Grid located in Component I, Part 3 article 1.4.

Q 45:

1. We are two existing TBIPS SA holders that will be bidding as a JV. Please confirm whether or not we are considered a new TBIPS bidder or an existing TBIPS bidder with the option to make use of the Grandfather Certification.

2. Re M4: Are we required to submit invoices to substantiate our billing or is providing the required information in the suggested table format sufficient?

3. Re M4: Can we claim the entire value of the contract as long as the finish date falls within the 3 years from bid closing or can we claim only the portion of the contract that falls within the 3 years?

A 45:

1. You are considered a new bidder. The Grandfather Certification does not apply.
2. Bidders are not required to submit invoices with the bid submission and the suggested table format is sufficient. However, for verification purposes Canada may request the bidder to provide invoices to meet M.4.
3. The start and end date represent the range of time in which the invoices were submitted to the client (invoice date). Only the portion relevant to IPS can be used.

Q 46:

We have a couple of questions regarding the CPSS data entry forms for M.5 (Category – Substantiation):

1. Is “Contract/Project Reference #” a mandatory or optional field?
2. Please confirm that the “Name of Resource” field is optional as it was in EN578-055605/E (Ref: EN578-055605/E, AMD 007, Q&A 87-1)

A 46:

1. This field is optional. Bidders must ensure that the details provided are sufficient so that when the reference is contacted, he (she) can properly substantiate that the work was performed for the given category.
2. This field is optional.

Q 47:

1. With regards to adding unsubstantiated categories (so long as we have the required number of substantiated categories) does Canada have a preference that we provide these categories as newly substantiated? The reason I ask is that we can certainly provide references in all areas of the TBIPS streams but it would save our firm much time & hassle if we already qualify to add the additional categories as unsubstantiated. If Canada does have a preference for substantiated categories then we will certainly proceed with this method.

2. With regards to the DCC and references I am uncertain about the bottom portion of the request (simple text pasted below), ie:

- (i) what does subsidiary refer to in this case.
- (ii) Would the name of subsidiary be “Company X” and the name of resource be the consultant(s) provided to our above listed client for the category reference?
