This modification is raised to answer questions from bidders pertaining to this Request for Standing Offer (RFSO).

Question 1:

This RFSO states that it will establish a list of 8 Non-Aboriginal and Aboriginal Offerors and 3 solely Aboriginal Offerors. Are bidders allowed to submit as an Aboriginal and a Non-Aboriginal bidder for a total of two submissions?

Answer 1:

Yes as the « Main Stream Offerors » and the « Aboriginal Set-Aside Offerors » will be evaluated separately. A firm could qualify on both lists if they meet all of the requirements.

Question 2:

How are the call-ups determined? That is, for each requirement/call up issued, are they sent to both the Aboriginal and Non-Aboriginal Standing Offer holders?

Answer 2:

The use of either the « Main Stream Offerors » or the « Aboriginal Set-Aside Offerors » will be the Project Authority's decision. Once the decision is made, in order to issue a call-up, Public Works and Government Services Canada (PWGSC) will follow the Selection Methodology and Call-up Process identified in PART 7- Standing Offer and Resulting Contract Clause in the current Request for Standing Offer (RFSO) document.
