TITLE - Air Conditioning Units & Parts - RISO**PART 1 - GENERAL INFORMATION****1. Introduction**

The Request for Standing Offers (RFSO) is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Offeror Instructions: provides the instructions applicable to the clauses and conditions of the RFSO;
- Part 3 Offer Preparation Instructions: provides offerors with instructions on how to prepare their offer to address the evaluation criteria specified;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria which must be addressed in the offer, and the basis of selection;
- Part 5 Certifications: includes the certifications to be provided;
- Part 6 Security, Financial and Insurance Requirements: includes specific requirements that must be addressed by offerors; and
- Part 7 7A, Standing Offer, and 7B, Resulting Contract Clauses:

 7A, includes the Standing Offer containing the offer from the Offeror and the applicable clauses and conditions;

 7B, includes the clauses and conditions which will apply to any contract resulting from a call-up made pursuant to the Standing Offer.

The Annexes include the Requirement, the Basis of Payment, and any other annexes.

2. Summary

Regional Individual Standing Offer for the supply, delivery and off-loading of various types of Air Conditioning (AC) units including parts and components as required to the Department of National Defence (DND), 4 Wing Cold Lake, Cold Lake, Alberta.

DND, 4 Wing Cold Lake, currently has various types of AC units throughout their base. Units vary in size, style and manufacturer. The use of the term "AC unit" in this solicitation includes not only air conditioners but heat pumps, coolers and other types of cooling systems. The period of the standing offer will be for two (2) years with one (1) year option period.

This requirement is subject to the provisions of the World Trade Organization Agreement on Government Procurement, the North American Free Trade Agreement, the Agreement on Internal Trade, the Canada-Chile Free Trade Agreement and Canada-Peru Free Trade Agreement.

3. Debriefings

Offerors may request a debriefing on the results of the request for standing offers process. Offerors should make the request to the Standing Offer Authority within 15 working days of receipt of the results of the request for standing offers process. The debriefing may be in writing, by telephone or in person.

PART 2 - OFFEROR INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the Request for Standing Offers (RFSO) by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Offerors who submit an offer agree to be bound by the instructions, clauses and conditions of the RFSO and accept the clauses and conditions of the Standing Offer and resulting contract(s).

The 2006 (2014-03-01) Standard Instructions - Request for Standing Offers - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the RFSO.

2. Submission of Offers

Offers must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the Request for Standing Offers.

3. Enquiries - Request for Standing Offers

All enquiries must be submitted in writing to the Standing Offer Authority no later than ten (10) calendar days before the Request for Standing Offers (RFSO) closing date. Enquiries received after that time may not be answered.

Offerors should reference as accurately as possible the numbered item of the RFSO to which the enquiry relates. Care should be taken by offerors to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that offerors do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all offerors. Enquiries not submitted in a form that can be distributed to all offerors may not be answered by Canada.

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least 15 days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

4. Applicable Laws

The Standing Offer and any contract resulting from the Standing Offer must be interpreted and governed, and the relations between the parties determined, by the laws in force in Alberta.

Offerors may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their offer, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the offerors.

PART 3 - OFFER PREPARATION INSTRUCTIONS

1. Offer Preparation Instructions

Canada requests that offerors provide their offer in separately bound sections as follows:

Prices must appear in the financial offer only. No prices must be indicated in any other section of the offer.

Canada requests that offerors follow the format instructions described below in the preparation of their offer.

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to that of the Request for Standing Offers.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process Policy on Green Procurement

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

- (b) An evaluation team composed of representatives of Canada will evaluate the offers.

1.1. Technical Evaluation

Failure to meet any of the following mandatory criteria at solicitation closing will render your submission non-compliant and given no further consideration.

1.1.1 Mandatory Technical Criteria

Ability to perform the full scope of the work, as described in Annex A.

1.2 Financial Evaluation

The Financial Evaluation, Annex B – Part 2 will be used for evaluation purposes only.

1.2.1 The Total Evaluated Offer price will be calculated as follows:

(a) The firm unit prices will be extended by their applicable line item quantity to obtain a total extended line item price. The total extended line item prices will be added together to reach a total price for those line items.

(b) Parts and material discount for miscellaneous items will be subtracted from the parts and material costs using the following formula:

Cost of parts and material x (1 (discount%))

Example: A discount of 10% with cost of parts and material of \$25,000.00, would be calculated as such:

$$\$25,000.00 \times (1 - .10) = \$22,500.00$$

(c) The total from (a) and the total from (b) will be added together to reach a Total Evaluated Offer Price.

2. Basis of Selection

- 2.1 Public Works and Government Services Canada may issue up to three (3) standing offers in order to fulfil the entire requirement.
- 2.2 The offeror is required to fully complete Annex B – Basis of Payment, Part 1 and Part 2.
- 2.3 An offer must comply with the requirements of the Request for Standing Offers and meet all mandatory technical evaluation criteria to be declared responsive. The responsive offer with the lowest evaluated price will be recommended for issuance of a standing offer.
- 2.4 The offeror with the lowest evaluated price will be given a higher ranking than the offeror with the next lowest evaluated price, who will be ranked higher than the third lowest evaluated price. The ranking of the three lowest compliant offerors will be identified in Annex C.
- 2.5 Only the first ranked supplier will be required to supply the cylinders identified in Annex A.

PART 5 - CERTIFICATIONS

Offerors must provide the required certifications and associated information to be issued a standing offer.

The certifications provided by offerors to Canada are subject to verification by Canada at all times. Canada will declare an offer non-responsive, will have the right to set-aside a standing offer, or will declare a contractor in default in carrying out any of its obligations under any resulting contracts, if any certification made by the Offeror is found to be untrue whether made knowingly or unknowingly during the offer evaluation period, during the Standing Offer period, or during the contract period.

The Standing Offer Authority will have the right to ask for additional information to verify the Offeror's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Standing Offer Authority may render the Offer non-responsive, may result in the setting aside of the Standing Offer or constitute a default under the Contract.

6. Identified Users

The Identified User authorized to make call-ups against the Standing Offer is authorized personnel of 4 Wing Cold Lake as determined by the Project Authority.

7. Call-up Procedures

7.1 Multiple Standing Offers: The Offeror acknowledges that multiple Standing offers have been issued for this requirement.

The call-up procedures require that when a requirement is identified, the identified user will contact the highest-ranked offeror to determine if the requirement can be satisfied by that offeror. If the highest-ranked offeror is able to meet the requirement, a call-up is made against its standing offer. If that offeror is unable to meet the requirement, the identified user will contact the next ranked offeror. The identified user will continue and proceed as above until one offeror indicates that it can meet the requirement of the call-up. In other words, call-ups are made based on the "right of first refusal" basis. Regional Individual Standing Offer for the supply, delivery and off-loading of various types of Air Conditioning (AC) units including parts and components as required to the Department of National Defence (DND), 4 Wing Cold Lake, Cold Lake, Alberta.

The Department of National Defence (DND), 4 Wing Cold Lake currently has various types of AC units throughout the base. Units vary in size, style and manufacturer. The use of the term "AC unit" in this solicitation includes not only air conditioners but heat pumps, coolers and other types of cooling systems.

Purpose:

DND would like the ability to purchase various types of AC units and parts to maintain their existing assets.

- AC units that are rated above 5 Ton will only require parts and components for existing units.
- AC units that are rated below 5 Ton may require the replacement of the entire unit or parts.
 - Replacement AC units must be compatible or interchangeable with existing systems and have the same output. The DND technical authority will determine if it is the whole system or specific parts that need to be replaced as per the call-up.
- Miscellaneous items for all AC units and consumables may also be required. These items will be indicated on call-ups from identified users if needed.
