Question #6(multi-part question)

A) The elevation of the basement on drawing A-201 isn't right according to the scale. Please clarify.

B) On drawing A-202, section 4, room 166N, the dash lines illustrating the concrete slab indicates that it needs to be demolished as opposed to drawing A-402 and drawing S7, section 2 where it his shown as existing concrete slab. Please clarify

C) The elevation of platform 2 and platform 6 on drawing A-401, section 2 isn't right according to the scale and the other elevations. Please clarify
