Replace 026100.02-2.1.3.2 with:

2.1.3.2: Import material standards as follows:

2.1.3.2.1 Import fill materials for the uplands (ie non-sediment) of the Site must originate from a clean source and be the lesser of the Canadian Council of Ministers of the Environment (CCME) Soil Quality Guidelines for Commercial and Industrial Land Uses, and the British Columbia Contaminated Sites Regulation (BC CSR) Schedule 7- Standards Triggering Contaminated Soil Relocation Agreements, Soil Relocation to Nonagricultural Land.

2.1.3.2.2 Import fill materials for the sediment (ie particulate material that usually lies below water) of the Site must originate from a clean source and be the lesser of the Canadian Council of Ministers of Environment (CCME) Sediment Quality Guideline for the Protection of Aquatic Life, Marine Environment, Interim Sediment Quality Guidelines, and the British Columbia Contaminated Sites Regulation (BC CSR) Schedule 9 - Generic Numerical Sediment Criteria, Marine and Estuarine Environment, Typical.

2.1.3.2.3 Import fill materials for the Site must originate from a clean source and must have a Sulphide-S content < 0.3%; have a Paste pH > 5.5; and have a Neutralization Potential Ratio (Neutralization Potential/Acid Potential) > 2.

All other terms and conditions remain unchanged.
