## **ANSWER 2**

It is unclear to me where in the solicitation documentation the time zones are varied. However, the closing is set for April 15<sup>th</sup>, 2014 Mountain Daylight Savings Time. (Edmonton local as that is where the documentation is to be received)

## **QUESTION 3**

Regarding Separate Prices, can the owner, at his discretion accept or decline one, some or all of the separate prices tendered?

#### **ANSWER 3**

The lowest compliant bid for the combined total price of all items will be deemed the successful bidder.

Please note that the mandatory work includes line items 1, 2, 3, 6, 7, (see items below)

- 1. Trailer move from Salmon Arm to Winnipeg
- 2. Trailer move from Winnipeg to Wabowden
- 3. Set-up of cells on site
- 4. Remove exterior siding and Supply & Install new siding
- 5. Re-Configuration of HVAC system
- 6. All other Renovations
- 7. Cash Allowances as outlined in the Specs (which include moving Detachment contents, Testing, and unforeseen conditions) Set at \$165,000

Items 4 and 5 will also be awarded to the lowest combined compliant bidder when it has been determined that funding is available. (To be determined during the evaluation process – before award of the contract)
