This amendment is raised to answer questions received from industry and to make the following changes to the document:

Section 1 Questions/Answers

Q1: The required weight capacity of monitor holders seems excessive. Can you specify the type of monitor being used and the actual weight of each monitor? Clamp mounted monitor holders typically should not be used for the kind of weight limits specified (24 lbs each with combined total of 48lbs).

A1: Refer to Section 2, article 3.

Q2: What type of work surface is in use? Is the material strong enough to handle the potential load when holders are rear clamp mounted to the surface? 48 lbs Leveraged by the 18" extension of the arms?

A2: Yes, please refer to Section 2, article 3.

Q3: Can you clarify that you are actually looking for a "clamp mount" (where the clamping device wraps **around** the outside of the rear edge of the work surface) versus a "Grommet mount" (where the Device is clamped **through** the work surface via an existing or installed grommet hole). I have attached a PDF diagram to clarify my meaning.

A3: Our worksurfaces will not have grommet holes. Clamp mount is required. Refer to Annex A, section 5.2.1 for more information.

Q4: Being a market leader in ergonomic products and workstation evaluations, we have looked over the specifications requested for the keyboard managers and we feel that the point of asking for a 15% forward tilt of the tray, doesn't meet a proper ergonomic position for the employee to be in a comfortable environment. This as our certified ergonomists would tell us, could cause carpal tunnel syndrome due to the flexing of the wrists. It would put a strain on the carpal tunnel veins and in the long run would cause numbness in the hands and then a carpal tunnel operation could arrive from this. The proper position should be the neutral position or a slight negative position of 10 degrees. Please advise us if this modification to the specifications could be modified.

A4: Refer to section 2, article 4.

Q5: The specifications ask for a height adjustment of up to 5" below the desk level. A fully actuating keyboard manager will offer from a 3"- 5" adjustment depending on the brand. A 3" adjustment would suffice for a person that is 4'6" tall. We agree that there needs to be multiple height adjustments due to people's height differences but would like to ask if the specifications can be modified to read up to 3" below the desk level. Asking for 5" would limit your choice of products to choose from.

For Section I, please confirm the desired composition of the required three (3) copies – how many hard and how many soft copies?

A6: 3 copies are required of either hard or soft copy as indicated.

Q7: At Part 4 Evaluation Procedures and Basis of Selection, 1.1.1.A: *Mandatory Technical Specifications Criteria (MTS)*, MTS1.2:

The Bidder must submit the documents required in MTS1.1 in soft copy (CD/DVD or USB format) or hard copy, written in Adobe Acrobat PDF version 7 or older.

Will you accept documentation provided in both soft and hard copies?

A7: Yes.

Q8: Annex A 5.2.9, Our Monitor Arm is manufactured from diecast aluminum. Diecasting for office furniture components is a process which results in the same quality and strength of components as forging. Will diecast aluminum be acceptable?

A8: Yes, diecast aluminum is acceptable.

Q9: Annex A 5.2.7, "Each extendable monitor arm must be able to be tilted a minimum of 180 degrees". Do you mean rotated 180 degrees from landscape orientation to portrait orientation since tilted upwards and downwards so that the monitor would face either the ceiling or the worksurface, would serve no functional purpose? Please confirm.

A9: We require a swivel minimum of 180 degrees in both orientations.

Q10: The minimum weight requirement exceeds the industry standard by over 16%; the standard is 20lbs for monitors up to 711mm (28in). Typically, monitors in the 27-29in space weight between 12 to 17lbs. Would you accept a dual monitor arm that can accommodate a monitor up to 38in wide, to a maximum weight of 20lbs?
