I would like to know if it would be possible to allow the design teams who submit their qualifications to include more photographs for each project provided as example of past work.

On page 16 of your document, section CC2, you only allow us one half page, 8 ½ inch X 11 inch for each similar project. Since your monument is of a large scale, don't you think that it would be more appropriate for you and for us to allow us more photographs such as a full page (8 ½ inch X 11 inch) for each project submitted? By permitting this, we can easier demonstrate to you the quality of work and it will be easier for you to understand the correlation between the budget and the project description of examples of past work submitted
