PART 1 - GENERAL INFORMATION

1. Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications: includes the certifications to be provided;
- Part 6 Security, Financial and Other Requirements: includes specific requirements that must be addressed by bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Statement of Work, the Basis of Payment, the Security Requirements Checklist, DND 626 Task Authorization Form and any other annexes.

2. Summary

2.1 Background

The Canadian Forces (CF) are regularly required to select equipment to support their operations. Sensors are an integral part of the electro-optical systems used to detect and locate threats. One of Defence Research and Development Canada (DRDC)'s mandates is to support the CF in its electro-optical system acquisition process by technically translating their operational needs, evaluating the performance of sensors currently in use, evaluating the potential of sensors from emerging technologies, analyzing options and issuing recommendations.

Sensor performance is evaluated in four ways, depending on time and objectives:

1. Laboratory characterization of basic sensor parameters via quantitative measurements;
2. Exterior testing to emulate sensor performance in conditions similar to those encountered in operation (e.g. low light, natural spectral content, difficult environment, etc.);
3. Sensor performance modelling; and
4. Laboratory application of comparative evaluation methods to measure performances similar to those encountered in operation. The last method is included in activities that aim to develop new methodologies for performance characterization representative of those encountered in an operational environment.

Another DRDC mandate is to find methods for improving vision system performance. This field includes the development of image processing algorithms that modify the local dynamic or contrast mapping, or that compress images to make them easier to transmit on a network. The performance of the algorithms developed is then evaluated using processing and image analysis software.

2.2 Objective

The objective of this statement of work is the provision of scientific and engineering services to:

1. Develop new characterization methods to more accurately evaluate performance in operating environments of electro-optical systems covering spectral bands from ultraviolet (UV) to infrared and including image intensifier systems (I2); and
2. Develop image processing algorithms to improve the performance of vision systems and measure their impact on image quality.

The work shall be completed at the DRDC Valcartier site.

2.3 Additional information

The organization for which the services are to be rendered is Defence Research and Development Canada - Valcartier (DRDC - Valcartier).

The period of the Contract is from date of Contract to March 31st, 2017, inclusive.

Estimated amount of available funding for this contract: \$840,000.00, Applicable Taxes extra.

The Contractor shall use DRDC Valcartier ultraspecialized testing equipment to test, among other things, classified electro-optical equipment and controlled goods. As a result, the classified and unclassified work must be done on-site at DRDC Valcartier.

Canada has determined that any intellectual property rights arising from the performance of the Work under the resulting contract will belong to Canada.

Bidders must provide a list of names, or other related information as needed, pursuant to section 01 of Standard Instructions 2003.

For services requirements, Bidders in receipt of a pension or a lump sum payment must provide the required information as detailed in article 3 of Part 2 of the bid solicitation.

The requirement is subject to the provisions of the Agreement on Internal Trade (AIT).

The requirement is limited to Canadian services.

This procurement is subject to the Controlled Goods Program.

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual*(<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2014-03-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile to PWGSC will not be accepted.

3. Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPS, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

Definitions

For the purposes of this clause,

"former public servant" is any former member of a department as defined in the [Financial Administration Act](#), R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;
- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"lump sum payment period" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"pension" means a pension or annual allowance paid under the [Public Service Superannuation Act](#) (PSSA), R.S., 1985, c.P-36, and any increases paid pursuant to the [Supplementary Retirement Benefits Act](#), R.S., 1985, c.S-24 as it affects the PSSA. It does not include pensions payable pursuant to the [Canadian Forces Superannuation Act](#), R.S., 1985, c.C-17, the [Defence Services Pension Continuation Act](#), 1970, c.D-3, the [Royal Canadian Mounted Police Pension Continuation Act](#), 1970, c.R-10, and the [Royal Canadian Mounted Police Superannuation Act](#), R.S., 1985, c.R-11, the [Members of Parliament Retiring Allowances Act](#), R.S., 1985, c.M-5, and that portion of pension payable to the [Canada Pension Plan Act](#), R.S., 1985, c.C-8.

4. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority, helene.lemay@tpsgc-pwgsc.gc.ca no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

5. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Quebec.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

6. Basis for Canada's Ownership of Intellectual Property

Development and Research for Defence Canada (DRDC) Valcartier has determined that any intellectual property rights arising from the performance of the Work under the resulting contract will belong to Canada on the following grounds:

Canada requests that bidders provide their bid in separately bound sections as follows:

Section II: Financial Bid (**two (2)** hard copies)

Section III: Certifications (**one (1)** hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

1.1 Section I: Technical Bid

In their technical bid, bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability and describe their approach in a thorough, concise and clear manner for carrying out the work.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that bidders address and present topics in the order

of the evaluation criteria under the same headings. To avoid duplication, bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

1.2 Section II: Financial Bid

1.2.1 Bidders must submit their financial bid in accordance with the following :

- (a) **Pricing** : Bidders must submit a firm all-inclusive hourly rate for each resource proposed, for each year of the contract period.
- (b) The information must be provided in accordance with the Basis of Payment in Annex B.
- (c) No travel and living expenses will be paid for services provided within the Quebec Region (including DRDC Valcartier facilities.) Further, Canada will not accept any travel and living expenses for travel between the contractor's place of business and the Quebec region (including DRDC Valcartier facilities). All these cost must be included in the firm all-inclusive hourly rates.
- (d) Prices must be in Canadian dollars, Applicable Taxes excluded, FOB destination, Canadian customs duties and excise taxes included.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. Evaluation Procedures

- a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- b) An evaluation team composed of representatives of Canada will evaluate the bids.

1.1 Technical Evaluation

Except where expressly provided otherwise, the experience described in the bid must be the experience of the Bidder itself (which includes the experience of any companies that formed the Bidder by way of a merger but does not include any experience acquired through a purchase of assets or an assignment of contract). The experience of the Bidder's affiliates (i.e. parent, subsidiary or sister corporations), subcontractors, or suppliers will not be considered.

1.1.1. Mandatory and Point rated Technical Criteria

Refer to Attachment 2, Mandatory and Point Rated Technical Criteria.

1.2 Financial Evaluation

1.2.1 Mandatory Financial Criteria

- a) Bidders must submit a firm all-inclusive hourly rate for each key resource proposed and for each category of resources, for each year of the contract period.
- b) The information must be provided in accordance with the Basis of Payment in Annex B.

1.2.2 Evaluation of Price

The price of the bid will be evaluated in Canadian dollars, the Goods and Services Tax or the Harmonized Sales Tax excluded, FOB destination, Canadian customs duties and excise taxes included.

For evaluation purposes only, the price of the bid will be determined as detailed in Attachment 1, Evaluation of Price.

2. Basis of Selection

2.1 Basis of Selection - Highest Combined Rating of Technical Merit and Price

1. To be declared responsive, a bid must:
 - a) comply with all the requirements of the bid solicitation;
 - b) meet all mandatory criteria; and
 - c) obtain the required minimum points specified for each criterion and each group of criteria for the technical evaluation, and
 - d) obtain the required minimum of 120 points overall for the technical evaluation criteria which are subject to point rating.

The rating is performed on a scale of 180 points.

2. Bids not meeting a) or b) or c) or d) will be declared non-responsive.
3. The selection will be based on the highest responsive combined rating of technical merit and price. The ratio will be 60 % for the technical merit and 40% for the price.
4. To establish the technical merit score, the overall technical score for each responsive bid will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 60 %.
5. To establish the pricing score, each responsive bid will be prorated against the lowest evaluated price and the ratio of 40%.
6. For each responsive bid, the technical merit score and the pricing score will be added to determine its combined rating.
7. Neither the responsive bid obtaining the highest technical score nor the one with the lowest evaluated price will necessarily be accepted. The responsive bid with the highest combined rating of technical merit and price will be recommended for award of a contract.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 60/40 ratio of technical merit and price, respectively. The total available points equals 180 and the lowest evaluated price is \$805,808.76.

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and associated information to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default in carrying out any of its obligations under the Contract, if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority may render the bid non-responsive or constitute a default under the Contract.

1. Certifications Required Precedent to Contract Award

1.1 Integrity Provisions - Associated Information

By submitting a bid, the Bidder certifies that the Bidder and its Affiliates are in compliance with the provisions as stated in Section 01 Integrity Provisions - Bid of Standard Instructions 2003. The associated information required within the Integrity Provisions will assist Canada in confirming that the certifications are true.

1.2 Federal Contractors Program for Employment Equity - Bid Certification

By submitting a bid, the Bidder certifies that the Bidder, and any of the Bidder's members if the Bidder is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "[FCP Limited Eligibility to Bid](http://www.labour.gc.ca/eng/standards_equality/eq/emp/fcp/list/inelig.shtml)" list (http://www.labour.gc.ca/eng/standards_equality/eq/emp/fcp/list/inelig.shtml) available from [Employment and Social Development Canada \(ESDC\) - Labour's](#) website.

Canada will have the right to declare a bid non-responsive if the Bidder, or any member of the Bidder if the Bidder is a Joint Venture, appears on the "[FCP Limited Eligibility to Bid](#)" list at the time of contract award.

2. Additional Certifications Required Precedent to Contract Award

The certifications listed below should be completed and submitted with the bid but may be submitted afterwards. If any of these required certifications is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to comply with the request of the Contracting Authority and to provide the certifications within the time frame provided will render the bid non-responsive.

STATEMENT OF WORK

1. General

1.1 Title

Development of Characterization Methodology for Electro-Optical Systems

1.2 Background

The Canadian Forces (CF) are regularly required to select equipment to support their operations. Sensors are an integral part of the electro-optical systems used to detect and locate threats. One of Defence Research and Development Canada (DRDC)'s mandates is to support the CF in its electro-optical system acquisition process by technically translating their operational needs, evaluating the performance of sensors currently in use, evaluating the potential of sensors from emerging technologies, analyzing options and issuing recommendations.

Sensor performance is evaluated in four ways, depending on time and objectives:

1. Laboratory characterization of basic sensor parameters via quantitative measurements;
2. Exterior testing to emulate sensor performance in conditions similar to those encountered in operation (e.g. low light, natural spectral content, difficult environment, etc.);
3. Sensor performance modelling; and
4. Laboratory application of comparative evaluation methods to measure performances similar to those encountered in operation.

The last method is included in activities that aim to develop new methodologies for performance characterization representative of those encountered in an operational environment.

Another DRDC mandate is to find methods for improving vision system performance. This field includes the development of image processing algorithms that modify the local dynamic or contrast mapping, or that compress images to make them easier to transmit on a network. The performance of the algorithms developed is then evaluated using processing and image analysis software.

1.3 **Objective**

The objective of this statement of work is the provision of scientific and engineering services to:

1. Develop new characterization methods to more accurately evaluate performance in operating environments of electro-optical systems covering spectral bands from ultraviolet (UV) to infrared and including image intensifier systems (I2); and
2. Develop image processing algorithms to improve the performance of vision systems and measure their impact on image quality.

The work shall be completed at the DRDC Valcartier site.

3. **SCOPE OF WORK**

Tasks 3.1 through 3.3, focus on test method development and improvement. Tasks 3.4 through 3.6 support the design of computer tools and assemblies for the measurement, analysis and improvement of images.

3.1 Development of test methods for image intensifiers or their components (e.g. I2 tubes) to more accurately evaluate performance in an operational environment.

3.3 Development of test methods for day/night vision sensors to more accurately evaluate performance in an operational environment.

The Contractor shall participate in the development of innovative characterization methods to evaluate performance in an operational environment of day/night vision sensors or their components. Day/night vision sensors include:

- a. Complementary metal–oxide–semiconductor (CMOS) sensors;
- b. Charge-coupled device (CCD) sensors;
- c. Electron-multiplying CCD (EMCCD) sensors;
- d. Sensors that function in UV; and
- e. Day sights, such as binoculars, sights or telescopes.

The Contractor's role includes:

3.5 Software development for data analysis

The Contractor's role includes:

- b. Developing data processing and analysis tools; and
- c. Developing data classification tools.

Software shall be developed in versions that are compatible with DRDC versions or using DRDC Valcartier commercial licences.

3.6 Development of image processing algorithms

The Contractor shall develop image-processing algorithms to improve the performance of vision systems. The Contractor's role includes:

4.4 Deliverables for task 3.6

Depending on the nature of the work, the deliverables shall be:

- c. Documentation for the functional software; or
- d. A user manual.

4.5 Publications

Any manuscript for publication in magazines, newspapers or other, including presentation summaries or other types of publication, shall be submitted to the technical authority for review and approval. An explicit reference regarding federal government funding must be included, and it must be clearly mentioned that the content is the authors' responsibility. The technical authority shall provide a written objection if there are specific elements (e.g. audience) that are not in the federal government's best interests. If the technical authority objects in writing, he/she shall send the written objection to the organization responsible for publication (the newspaper or conference).

5. MEETINGS

The Contractor shall organize the following meetings:

1. Preliminary task presentation meeting
2. Progress review meeting
3. Final task review meeting

The technical authority or an appointed DRDC Valcartier representative must chair the meetings listed above. The meetings will be held at DRDC Valcartier or at the Contractor's premises, as directed by the DRDC Valcartier representative. Videoconferencing can also be used. The technical authority and/or the Contractor, depending on the location of the meeting, must ensure that the required data, personnel and facilities are available for the meetings so they can be conducted in an efficient manner. Other informal meetings, if necessary, could be scheduled and held as required according to what was mutually agreed upon by the Contractor and the technical authority.

The Contractor must keep minutes of all formal meetings listed above. For informal meetings, minutes will be recorded if required, according to what was agreed upon by the Contractor and the Technical Authority. The meeting agenda and minutes must be prepared and submitted to the technical authority.

5.1 Preliminary task presentation meeting

A preliminary task presentation meeting must be held when a new task authorization is started. The meeting must involve the technical authority and additional technical members as appropriate and Contractor personnel. It aims at reviewing in detail the objectives of each task authorization. It could last up to two hours and must address all technical issues related to the task authorization to be done. The Contractor will be responsible for establishing the agenda and publishing the minutes of the meeting.

5.2 Progress review meeting

A progress review meeting must be held on a regular basis for the duration of the contract (as described in Table 1). The meeting can be held via teleconference unless otherwise directed by the technical authority or its representative. This meeting must involve the technical authority and the appropriate personnel from the Contractor. It aims at reviewing the effort made from a management perspective (i.e. schedule compliance, budget, etc.) for a specific period. The progress review meeting must be brief and focus on providing a status of recent tasks and issues without addressing detailed technical questions. These two documents (agenda and minutes) must be approved by DRDC Valcartier and published prior to the following meeting.

5.3 Final task review meeting

A final task review meeting will be held upon completion of the project. The meeting will be held at DRDC Valcartier unless otherwise directed by the technical authority (upon agreement between technical authority and the Contractor, meetings could be held in the latter's premises). The meeting aims at reviewing the effort made during the entire task authorization from a management perspective. It could last up to half day and must provide a detailed overview of all tasks and issues without addressing specific technical aspects. The Contractor will be responsible for establishing the agenda and publishing the minutes of the meeting.

3 - Cost of labour :

To establish labour costs, the effort available in terms of hours (see last column in Table 4.1, below) must be determined. The effort available for each resource category will be calculated as follows:
