Amendment #3 to Solicitation 201405579 has been issued to extend the closing date and respond to **Questions and Answers – Part 3** as follows:

The closing date has been extended to **April 30th, 2014 at 2:00pm EST** in good faith due to the Easter Holidays potentially affecting submission of proposals. There is no intention to extend the Solicitation beyond this date.

Questions and Answers – Part 3:

Q38: With regards to the security requirement, does it only apply to the project manager, site supervisor, people attending meetings, or others performing services? Given the large number of resources in the provision of services, can you tell us the types of key people who will need to meet this requirement?

A38: Every resource (consultant, and sub-consultant) working on site will require the necessary security clearance.

Q39: We respectfully request clarification on how call-ups will be distributed?

A39: Call-ups will be issued using Right of First Refusal. The top ranked firm in each Discipline/Region will be given the first opportunity to perform the services. If they are unable to perform the services as per the requirement, then the 2nd ranked firm will be given the opportunity. If the 2nd ranked firm is unable, then finally, the 3rd ranked firm will be given the opportunity.

Q40: How will demonstrated experience be evaluated?

A40: Please see Annex “D” – Evaluation Criteria for information.

Q41: Despite A35A. (Amendment 2), we would like to know, in response to these requirements, if we are allowed to use the format we want (as long as it is on 8.5x11 sheets), or should we be using the table provided within Annex D? Or should we consider this table as a tool that will most likely be used by the evaluation team?

A41: As per Annex “D” – Evaluation Criteria, the instructions are clear as to what format to use.

Q42: Through Rated Requirement R4, can we demonstrate our experience performing services in our discipline with one project having an overall contract value more than \$250K CAD? Should this project be completed or can it be on going?

A42: Yes, you may use only one (1) project; however, the project must be completed.
