This amendment (1) seeks to update the terms and conditions as well as answer vendors' questions.

1) At **Part 4, 1.1 Mandatory Technical Criteria**, add the following:

1.1.1 - Manufacturer Letters and Manufacturer's Suggested Retail Price (MSRP) Lists

It is the Offeror's responsibility to obtain the co-operation of the highest ranking Distributor(s) and/or Manufacturer representative to ensure the Offeror submits the same MSRP list in the authorization letters as other Offerors.

If the MSRP lists from a particular Manufacturer are not consistent from each of its dealers offers, the equipment discount percentages offered cannot be evaluated fairly. For this reason PWGSC may seek clarification directly from the Manufacturer, but is not obligated. If discrepancies in the letters and/or MSRP price lists exist, PWGSC has the right to reject all or some of the Offeror submissions (specific to the MSRP in question) not meeting the requirements outlined above regardless if the Manufacturer has or has not been contacted for clarification.

Where a Distributor, and not a Manufacturer, has sole and exclusive rights to grant dealer authorizations, set national pricing and to promote and supply Manufacturer's products across Canada, the Distributor may act on behalf of the Manufacturer to provide all the necessary RFSO dealer authorization letters and MSRP list.

2) Question and answers

Q1. A number of the manufactures listed in tender have more than one discount. An example is the Schlage electronics I have four different discounts under that product line. Can I provide you a discount sheet per manufacture?

A1. Only one discount per manufacture/MSRP is required

Q2. You are requesting an hourly installation rate but Lock Distributors do not have installers. Is this something you would consider removing from the Tender?

A2. There is a requirement for installers. See Part 3, subsection 1.3

Q3. If we are able to offer installation services in Ontario and Quebec but not in the other provinces can we still bid ? If yes where should we indicate this ?

A3. Please see Part 3, subsection 1.3.

Q4. If our installer is authorized to sell one of the 29 manufacturers (example MEDECO therefore the MFGR letter would be in the installers name and not our name) can we indicate this in our bid or should we exclude this specific manufacturer from our bid ?

A4. As per Annex "A", To be considered responsive, you must provide a written proof (Annex "C" from at least 23 of the manufacturers listed below that you presently have a direct account with the manufacturer, or that you are the manufacturer's exclusive Canadian agent for your region.

Q5. Regarding the rate for installation – Can we sub-contract the installation to a 3rd party? We can still charge for the installation but have it sub-contracted it out.

A5. Yes, as long as you submit a the letter indicating sub-contractor as certified by the manufacturer in question.

Q6. Can we have annex C - appendix 1.0 an 2.0 "MFGR authorizes Offeror" in word document please so we can send it to the manufacturer?

A6. Yes, send an email to the contracting authority to obtain a copy. However, please be advised that the letters are not to be modified IN ANY WAY other than filling in the blanks. A modified letter will be considered as non-compliant.

Q7. In annex A, there is a request to provide 23 written proof of the 29 listed items, some of these items are by the same manufacturer. Can they be grouped together?

A7. No.

Q8. Labour rate: is the labour rate for the national capital only or cross the country? As you know the labour rate is different depend on the location. If the labour is to be across the country should we give one price or price per province?

A8. We require one rate.

Q9. Abus, HPC, Ilco, Kaba, mass Hamilton, McKinney, master, Pannex are off the shelf items. The manufacturer doesn't sell directly to integrator they only sell to suppliers, which most of the integrator buy from. Most of the time they do not have MSRP list, how would you like us to price it?

A9. It is the offeror's responsibility to obtain the necessary documents requested in the solicitation.

Q10. How would you like to receive the price list, as some manufacturer have over 50 pages per product.

A10. Price lists can be sent electronically on a CD/DVD or USB key

Q11. In annex A, the Medeco cylinders and keys have different keyways across the country. How will the contract winner have access to all these keyways?

A11. It will be up to the Client departments with restricted keyways to inform the manufacturer.
