## QUESTIONS AND ANSWERS

### Question 5

Re paragraph 1.7.4. Is the intention of this paragraph to say that there may be two separate contracts - one for the architect and one for the artist? OR to say that there may be an additional contract with additional artist fees above the estimated \$255K?

### Answer 5

Article 1.7.4, explains that Canada, at its sole discretion, may award a contract to the artist for the fabrication of artistic elements. The value of this contract would be included in the all-inclusive budget for the Project, but would not be part of the Successful Proponent contract value estimated at \$410,000 (see amendment above).

All other terms and conditions remain the same.
