Q.4 Can you send me a piece of this fabric so I can have my technicians inspect the fabric so we can provide Canada the best possible pricing. ..."

A.4 No sample will be provided. Use the complete technical specifications

Q.5 Seing that this contract is a standing offer and that there are no guarantees that it will be exercised in full. I would like to point out that our minimums are in increments of 500 m and that lead times are of 4 to 6 weeks for the fabric alone and then one must add at least another 2 weeks for lamination and testing

Q.6 I would also ask that supplier minimums be considered when making call-ups, in that these call ups should be made in increments of 500m so as to not have material in inventory that may not get called-up due to different increments in the minimums.
