Request for Proposal #1000308061 - Lift-Truck Maintenance and Repair Services

This amendment consists of questions and answers and amendments to the RFP.

Section 1 - Questions and Answers:

- Q1: Can the bidder submit one single proposal (with all required copies) and one financial proposal, to bid on all five regions?
- A1: Yes. Please reference section 4.1 General of Part 4 Evaluation and Selection:

"Bidders may submit a proposal for one (1) or more of the regions listed below. However, bidders must submit prices/rates for all the services for all the sites listed in the Region for which the bidder chooses to submit a proposal."

- Q2: Is the contractor to supply the test weights for load tests or will CRA have them available for use at each site?
- **A2:** The Contractor must bring all necessary equipment to conduct the load test. Please reference Section 2 General Requirements, of Annex A: Statement of Work;

"As part of the maintenance and repair services, the Contractor must supply all required chemicals, tools, and accessories (including but not limited to Battery Rollers) to perform all services."

- Q3: If contractor is to supply the weights, will CRA pay for the freight as required to transport said weights when needed?
- A3: No. Please reference Attachment 2: Financial Proposal:

"Bidders must quote a firm all-inclusive annual rate for each powered lift-truck specified in Annex A-1 "CRA Sites and Powered Lift-Truck Count", in Canadian funds, GST or HST extra if applicable, for the provision of Annual & Semi-Annual Maintenance Services in accordance with Annex A - Statement of Work.

The firm all-inclusive annual rates must include all labour and equipment costs required to provide the Annual & Semi-Annual Maintenance Services in accordance with Annex A "Statement of Work"."

- Q4: If yes, can you please provide a line to quote this in the financial proposal or will it be considered an extra, inside the contract to be addressed as required, per site?
- A4: Please see A2 and A3.
- **Q5:** The financial proposal only allows for one 'firm rate per training session' to be quoted. We offer various course rates, based on quantity of attendees. For the purpose of consistency for this tender, can you please specify the quantity of people to be trained (ie 10 max)?
- **A5:** Please see Section 2 Amendments to the RFP, below. Please note that the Financial Proposal section and electronic file have been modified.



- **Q6:** Is water, appropriate for filling lead acid batteries, readily available/accessible and in close proximity to the lift trucks?
- **A6:** Please reference Section 2 General Requirements and Section 3.2 Monthly Battery and Charger Services of Annex A: Statement of Work:

"The Contractor must perform maintenance and repair services in accordance with the OEM's guidelines/instructions."

"The Contractor must supply all required chemicals, tools, and accessories (including but not limited to Battery Rollers) to perform monthly battery and charger services. The Contractor must report any deficiencies with any batteries or chargers to the CRA, along with any recommended repairs to address the deficiencies."

- Q7: Does Semi-Annual maintenance include all parts and labour, required to ensure that each "lift truck is restored to fully functional operation" or is Semi-Annual maintenance expected to be only a check, with all deficiencies being reported to CRA, and addressed separately?

"The costs, as specified in the basis of payment, include all parts and labor to perform the services listed below, save and except for any deficiencies and recommended repairs reported by the Contractor to address these deficiencies, as specified below."
