This amendment (2) seeks to update the terms and conditions as well as answer vendors' questions and extend the end date to 2014-05-09.

1) At **Part 4, 1.1 Mandatory Technical Criteria**, delete in its entirety and replace with the following:

1.1.1 - Manufacturer Letters and Manufacturer's Suggested Retail Price (MSRP) Lists

It is the Offeror's responsibility to obtain the co-operation of an authorized Distributor(s) and/or Manufacturer representative to ensure the Offeror submits the same MSRP list in the authorization letters as other Offerors.

If the MSRP lists from a particular Manufacturer are not consistent from each of its dealers offers, the equipment discount percentages offered cannot be evaluated fairly. For this reason PWGSC may seek clarification directly from the Manufacturer, but is not obligated. If discrepancies in the letters and/or MSRP price lists exist, PWGSC has the right to reject all or some of the Offeror submissions (specific to the MSRP in question) not meeting the requirements outlined above regardless if the Manufacturer has or has not been contacted for clarification.

Where a Distributor, and not a Manufacturer, has sole and exclusive rights to grant dealer authorizations, set national pricing and to promote and supply Manufacturer's products across Canada, the Distributor may act on behalf of the Manufacturer to provide all the necessary RFSO dealer authorization letters and MSRP list.

2) At Annex "C", delete Appendix 2.0

3) At Annex "A",

Delete the following line items: **i.** Lori; **ii.** Lori less cylinder; **iii.** Mass Hamilton

Insert the following line items:

i. Ilco - Brass Cylinders, Security Hardware Cam and Specialty Lock Locksmith Supplies

ii. Ilco - Simplex Unican

4) Question and answers

Q12- For Annex "C", can we group manufacturers together?

A12- Yes, for Annex "C" only, they can be grouped together on the letter.

Q13- I would like to know the shipping locations.

A13- Shipping locations will be indicated in the subsequent call-ups sent to standing offer holders.

Q14. Under Appendix 2.0, most of these Manufacturers do not know who is doing the install of their product, so how would the Manufacturer be able to provide a letter certifying the installer in question.

Please note that Lori and Lori less cylinder are the same product line and no longer exist under the name Lori but fall under the company called Ilco and are found under the price list Brass Cylinders, Security Hardware Cam and Specialty Lock Locksmith Supplies. Please advise if we can make the appropriate changes under Annex "A" Requirement & Price Lists.

Q17. Can we please get clarification regarding the Manufacturer Ilco – are you referencing the Price List (Key Blanks, Key Assortments, Key Machines) or Price List (Aluminum Store, Front Hardware) or Price List (Brass Cylinders, Security Hardware Cam and Specialty Lock Locksmith Supplies) or Kaba Simplex (Unicans) found under price List (Simplex Catalog – Kaba Access and Data Systems Americas).

A17. Please see point #3. Only one discount per manufacturer is required.

Q18. Can we please get clarification on getting the letter signed by the highest Ranking Authorized Representative.

A18. Please see point 1 of this amendment.

Q19. In amendment #1, you indicated that the letter "are not to be modified IN ANY WAY other than filling in the blanks. A modified letter will be considered as non-compliant." Some of the manufacturers will not sign any other letter than their own. If all of the necessary information is there, can we submit their letter instead?
