QUESTIONS AND ANSWERS**QUESTION 4**

I have a question about the responses that are required for the One-On-One meetings. The RFP states:
(Your answers will be used to help us to get prepared and to facilitate the discussion during the One on One meetings. Annex G must be submitted to the Contracting Authority at PANumerique.APDigital@tpsgc-pwgsc.gc.ca at least 3 business days before your One-on-One meetings.)

But in your note [details to Registered Participants] it says:

- a. Supplier responses to LOI Annex G: In accordance with the LOI, all registered suppliers must submit responses to the questions in LOI Annex G.

Due date for submission of LOI Annex G responses: May 5/14.

May 5th is before the Industry Day and well before our [scheduled] 1:1 meeting. We believe that we can provide more meaningful input after we have had a chance to consider all the materials that will be presented on the Industry Day. Can you please confirm that we have until 3 days before our One-on-One meeting for submitting our written response?

ANSWER 4

In order to assist the GC with logistics regarding the One-On-One (1:1) sessions all Registered Participants are asked to **submit an initial response to LOI Annex G by May 5/14.**

Registered Participants may revise the Annex G responses and resubmit 3 business days before their scheduled 1:1 session. For Registered Participants whose 1:1 sessions are scheduled May 7, 8 or 9, 2014, revised responses can be submitted either before, on or after their 1:1 session.

Registered Participants may revise the Annex G responses following their 1:1 session and may resubmit with the supplier's full feedback by the close date of the LOI.

Other interested suppliers may submit responses to Annex G, and any other feedback, anytime prior to the close date of the LOI.

Reminder: Feedback to this LOI can include responses to Annex G, as well as any other feedback the supplier feels is relevant to this initiative.
