QUESTIONS AND ANSWERS

Q1: Does the contractor need to be on-site or can the work be completed remotely?

A1: The contractor is required to work on site.

Q2: Does the contractor have flexibility to complete the work at any time during the day? Or does the contractor need to be available at certain times each day?

A2: No. The work may not be completed anytime during the day. The work is generally required between the hours of 5:30 a.m. and 9:30 a.m. to ensure posting of the media report on the dedicated site no later than 8:30 a.m. The contractor is also responsible to produce and distribute hard copies in-house no later than 9:00 a.m.

Q3: Is the estimated cost provided (\$100 - \$250K) an estimate for a 1 year contract or for a total of 4 years (1 year plus 3 options years)?

A3: The estimated cost provided is for a total of 4 years (1 year plus 3 options years).
