QUESTIONS AND ANSWERS

- Q1. Part 4 – Evaluation Procedures and Basis of Selection (Part 2 of 2 – Page 7 of 56)
Section 1.1.1 Mandatory Technical Criteria
2. Past Relevant Experience

Is it possible to submit less than 10 relevant projects and still be considered for the Standing Offer?

- A1. No. It is mandatory that the Offeror describe 10 relevant projects completed by the firm to substantiate its ability to meet this requirement (1.1.1).

- Q2. 3. Corporate Capability

- a) Is it possible to not submit an individual's name for one or more of the categories/specializations?
b) The section states that "All individuals must be in-house." However in Part 1, section 2 it states that it is possible for Offerors to Joint Venture. Kindly confirm if sub-contractor or joint venture staff may be used to meet one or more of the categories/specializations.

- A2. a) No. Individual's names must be provided for all 25 Specializations.
b) Staff employed by the joint venture firms are considered in-house. Sub-contractors are not considered in-house.

- Q3. Section 1.1.2 Point Rated Technical Criteria
2. Past Relevant Experience of the Firm

- a) Do all 10 projects have to have been completed for federal government clients?
b) Or could they have been completed for other levels of government clients or even non-government clients?

- A3. a) No.
b) Yes.

Completed projects for federal government clients may obtain additional points.

- Q4. Section 1.1.2 Past Relevant Experience of the Firm, Page 8 of the RFP

This item requires bidders to provide 10 relevant projects per Stream, demonstrating the full range of services requested. As our firm operates in all areas of the country, we have a wide range of projects to select from, including many from outside of Ontario. In order to score the maximum points allotted for this point-rated criteria, we face the dilemma of choosing between

an Ontario-based project which is not as representative technically, versus a "non-Ontario" project that better covers the required technical elements. Please provide guidance in selecting between Ontario-based vs non-Ontario based projects.

- A4. The 10 projects selected should demonstrate the full range of services. Projects demonstrating the full range of services in the province of Ontario may obtain additional points.
- Q5. Part 6.1 Security Requirement Page 11 of the RFP
This item requires that all of the Offeror's proposed candidates possess security clearance to have access to certain sites. It is understood that this clearance be in place at the RISO closing date. Please indicate to bidders how to demonstrate compliance with this item.
- A5. Please refer to Amendment No. 002 regarding revisions to the Security Requirement.

Prior to issuance of any Standing Offer, Bidders will be required to provide PWGSC with the CISC security clearance number or date of birth for each of the proposed candidates.
- Q6. Corporate Capability Table Form 3A(3): Specialty # 15, Specification Writer: Should the Specification Writer be CSC certified?
- A6. It is not mandatory that the Specification Writer be CSC certified.
- Q7. Form 3B: Please indicate the page limit for each CV.
- A7. Form 3B should read: "(On one sheet of paper, single-sided 8.5" x11)".
Please see Form 3B (Rev.1) attached.
- Q8. Annex "D" – Form 4: The page limits for each CV (2 pages for each CV for each of the 4 key personnel) and the stated total number of pages per stream (4 pages) do not seem to be consistent. Please clarify.
- A8. Form 4 is amended to read: "... 8 pages total per stream."
Please see Form 4 (Rev.1) attached.
- Q9. Section 1.1.1 Mandatory Technical Criteria: Under point 3, it is mentioned that all 25 individuals must be in-house.
Please clarify if utilizing sub-consultants for this proposal is allowed or not?
- A9. Sub-contractors are not allowed. Please refer to answer A2(b) above.
- Q10. Stream 3 includes a diverse set of professionals to provide the level of quality and service that PWGSC needs for this Stream. The requirement to make the Risk Assessor a Key Personnel employed by the Offeror restricts the level of competition in this Stream (we note that the Senior Risk Assessor Wildlife and Terrestrial is not a Key Personnel). It also severely limits the highly talented professional pool in the industry that Public Works will be missing on projects in Stream 3. The stream already includes a Senior Representative for the Offeror and other Key Personnel to ensure quality and accountability are achieved.

Would it be possible to allow for the Risk Assessor position to be provided by a sub-consultant to strengthen our Risk Assessment capacity in this Stream?
