This solicitation amendment is issued to make the following changes:

4. Term of Contract

4.1 Period of the Contract

The period of the Contract is from October 1, 2014 to September 30, 2015 inclusive.

4.2 Option to Extend the Contract

The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to two separate and additional one year periods at October 1, 2015 and October 1, 2016 under the same conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions as set out in the Basis of Payment.

Canada may exercise this option at any time by sending a written notice to the Contractor at least ten calendar days before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.

All other terms and conditions remain unchanged.
