AMENDMENT 001

The following Amendment is raised to answer questions posed concerning the RFP.

Q1. Would the Crown please provide justification for the 30 Km limit and reasons why a bidder who is 40 kms, 50 kms from Trenton or even as far as Kingston or Whitby would not be acceptable. What is the criteria for this requirement?

A1. As previously mentioned in the SOW of this RFSO, we require the repair facility to be within a 30 km radius to allow for in-progress inspections and acceptance during disassembly and repair. We are also limited by budget and personnel constraints and reducing unnecessary travel time and fuel costs is required. The vehicles we repair are used for 24 hour emergency and Operational Flight requirements and efficient turn around for repairs is essential for our strict timeline constraints.

Q2. Part 4 para 1(a), para 1.1, para 2 state the requirement to meet the Mandatory Technical Criteria; however, there are no Mandatory Criteria in this RFP. Can the Crown please provide the complete Mandatory Criteria that will be used to evaluate the bids?

A2. There are no Mandatory Technical Criteria to be evaluated for this requirement. Bids will be evaluated using the Financial Evaluation only.

Q3. Please identify the incumbent contractor, the duration of their contract and the dollar amount. If there is no current contract, please provide the same information for the last contract for these services.
