Question and Answer #1:

Q1

We would like to clarify that the winning proposal will have the opportunity to present the manufacturer's software licensing terms and restrictions that are not covered under the RFP.

A1

No. Please refer to article 2.2 Standard Instructions, Clauses and Conditions of the RFP which states: "Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of this solicitation and accept the clauses and conditions of the resulting contract."

Further, the certification at Appendix E of the RFP clearly indicates that: "...additions to the articles, clauses, terms and conditions contained or referenced in this RFP and/or Statement of Requirement and Bidder Response Form document will render the bid non-responsive.

Q2

A request was made to remove all of the Synergy requirements in the solicitation and specifically article 7.29 Liquidated Damages for Synergy Non-Compliance.

A2

The Synergy requirements and article 7.29 remain unchanged with the exception that they shall apply only to item 2 of the requirement for Simulations reduced functionality Software. The Synergy requirements will no longer apply to item 1 Simulations full functionality software. Reference to "software components" in all Synergy clauses only in the RFP means Item 2 – Simulations reduced functionality Software.

SOLICITATION AMENDMENT # 02

This solicitation amendment is raised to:

1. Update Article 1.4 entitled “ARIBA SUPPLIER NETWORK (ASN) MEMBERSHIP REQUIREMENT”.

THE SOLICITATION IS HEREBY AMENDED AS FOLLOWS:

Delete: Article 1.4 entitled “ARIBA SUPPLIER NETWORK (ASN) MEMBERSHIP REQUIREMENT” in its entirety and replace with:

1.4 ARIBA SUPPLIER NETWORK (ASN) MEMBERSHIP REQUIREMENT

The Canada Revenue Agency's (CRA) e-commerce solution for ordering, receiving and reconciling goods and services is an Ariba tool which has been branded internally as “Synergy”. Synergy may be used in this requirement in order to expedite the ordering process under any resulting contract.

The highest-ranked Bidder must become a member of the ASN if at CRA's sole discretion it is determined that the software components and related maintenance and support for **item 2 – Simulations reduced functionality Software** will be added to the Synergy catalogue. The Bidder would be required to maintain membership in the ASN throughout the period of any resulting Contract. All costs associated with this membership shall be borne by the Bidder.

Any requirements within the RFP and its associated documents related to Synergy must be met by the vendor if, at CRA's sole discretion, it is determined that the software components for **item 2 – Simulations reduced functionality Software** will be added as a Synergy catalogue. Reference to “software components” in all Synergy clauses only in the RFP shall mean Item 2 – Simulations reduced functionality Software.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
