Q29. Question

Is it the Government's intention to release the names of the teams that have qualified?

A29. Answer

It is expected that the list of qualified respondents may change following each intake date; therefore Canada anticipates publishing only the final list at the end of the RFRE process.

Q30. Question

I would like to make changes to my bid team to better meet Canada's requirements. What changes/modifications, if any, can be made to my bid team? For example, can I sub out a team member for one of my affiliates, parents, and/or subcontractors?

Q30. Answer

Yes. As permitted in RFRE clause 2.8.1, a Respondent can make a change to the identity of Persons comprising the Respondent, which can include substituting, adding and/or removing a Team Member, and/or Joint Venture Participant, by submitting a complete new Response prior to any of the Response Intake Dates, in accordance with RFRE clauses 2.8.2 and 2.8.3.
