Amendment 001 to Solicitation 21120-148947/A - Cook Chill Bags & Clips

The purpose of this amendment is to:

1. Address questions received from a bidder, with response back from Public Works and Government Services Canada; and
 2. Incorporate the change to delivery date.

Question 1:

The resulting contract clauses states that delivery must be made within 10 calendar days from receipt of a call-up against the Standing Offer. Would it be acceptable to extend this period to 21 days?

Answer 1:

Yes, the Correctional Service of Canada (CSC) is willing to extend the delivery period to 21 calendar days from receipt of a call-up against the Standing Offer.

Question 2:

In Annex "A" - Requirement, Article 4. - Specifications, it states that all sizes of cook-chill bags must be angle seal or handle seal. There are 3 types of seals that would fit this description - Angle Seal, Angle Seal w/ Handle, and Flat seal w/ Handle. Which type of seal would you like us to quote?

Answer 2:

It is at the Offeror's discretion what type of seal they quote. As per the specifications, the bags must be angle seal or handle seal (or could be both).

Delivery must be made within 21 calendar days from receipt of a call-up against the Standing Offer.
