Contract G9067-120003/003/XN was awarded to Systematix IT Solutions Inc. on October 18, 2012 for a total period of 480 days (plus two options periods of 240 days) for a total estimated cost of \$650,880.00 (taxes included) for (1) P.9 Project Manager. The resource under this contract performed this or similar services.

Canada confirms the Architect is a completely new position.

Question # 014:

Due to the complexity of this requirement would the Crown please consider providing vendors with a 1 week extension to the closing date of this RFP?

Under section 1.2 Summary, delete *b.* in its entirety and replace with:

b. It is intended to result in the award of up to eleven (11) contracts each for two hundred and forty (240) billable days, plus one (1) irrevocable option period of one hundred and twenty (120) billable days allowing Canada to extend the term of the contract(s).

Change 2)

Delete article 7.4 Contract Period in its entirety and replace with:

7.4 CONTRACT PERIOD

a. **Contract Period** : The "**Contract Period**" is the entire period of time during which the Contractor is obliged to perform the Work, which includes :

- i. The "**Initial Contract Period**", which begins on the date the Contract is awarded and ends two hundred and forty (240) billable days later ; and
- ii. the period during which the Contract is extended, if Canada chooses to exercise any options set out in the Contract.

b. **Option to Extend the Contract** :

- i. The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to one (1) irrevocable option period of one hundred and twenty (120) billable days under the same terms and conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions set out in the Basis of Payment.
- ii. Canada may exercise this option at any time by sending a written notice to the Contractor before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced, for administrative purposes only, through a formal contract amendment.
