This Solicitation Amendment 001 is raised to answer Bidder's questions and amend Annex B Basis of Payment.

Question 1:

This enquiry seeks clarification on a question about the pricing tables in Annex "B"

The instruction just above the Tables indicates that pricing for Item #3 and Item #4 is on an "as and when" requested basis, when the contractor is already on site for other work. Then, in the Tables, the first pricing line under Items 3 and 4 asks for a "Service Call" price. This line would seem redundant if we were already on site. Am I misinterpreting what is meant by a "Service Call"?

Answer 1:

The wording "when the contractor is already on site for other work" should be deleted.
