This amendment is raised to provide Questions and Answers that have been raised in regards to the solicitation. **As no contact has been made, there WILL BE NO BIDDERS CONFERENCE on Tuesday, May 27, 2014.**

Q1 Can you please clarify what Transport Canada (TC) certification is required?

- There are far too many TC Regulations to list which is why they are referenced in general. Basically the vessels have to be compliant with the rules and regulations as they pertain to their size and vessel type. Additional info can be found at <http://www.tc.gc.ca/eng/marine-menu.htm>.

Q2 What will be the total crew onboard at any one time?

- There will be a four person crew onboard consisting of a Vessel OIC and XO (adult staff), a buffer and engineer (staff cadets/yough) and approx. 8-15 traineess (cadets/youth).

Q3 Are the planned voyages to be day trips or longer in duration?

- Some of the voyages are day trips however there will also be a combinationof 3 and 5 day sea phases (overnight activities).

Q4 What is the mimuminum required number of bunks inside the vessel, based on a 45' vessel?

- The minimum number of bunks inside the cabin is four, with the remainder of the cadets sleeping in opo up tents on the main deck.

Q5 5.1.27 Trap Haulers and derricks shall be disabled or isolated to avoid accidental starting. Abd 5.1.28 Anchor windlass/winch system shall be function and accessible. This is contradicting

- The use of the trap haulers are required, but not the derricks (they are to remain disabled). During the handover, it is required that the owners provide a briefing to DND on how to use the trap haulers.

Q6 Toilet Can we keep our existing toilet and use it when the boat is 12NM offshore and then have a portable toilet for when the boat is within 12NM from shore? Or would we totally diable the existing toilet and use the provided Portable Toilet if we do not install a holding tank or MSD?

- The regulations state that we cannot have access to the other toilet, so the room has to be secured during the rental period. The deck space is restricted already. The deck is used for training, eating, and overnight sleeping so having a portable toilet placed ondeck would not meet

the overall requirement. Are you looking at placing a chemical toilet that can be dumped outside the 12NM? A chemical toilet placed in the current bathroom (current toilet removed) would provide the required privacy.
