The following solicitation amendment 7 is raised to provide an answer to a question received from a potential bidder.

Q1 M.2 for the Tester resource requests "A minimum of five (5) years of experience, within the last ten (10) years, in automated test script development."

R.3 also requests "Experience in automated test script development."

Scoring

1 to 3 years: 10 points

3+ years to 6 years: 15 points

More than 6 years: 20 points"

Given the requirements of M.2, the scoring for R.3 seems to be inaccurate and ineffective as all bidders would automatically be granted 15 points if M.2 was met. It makes more sense for R.3 to measure experience over and above the requirement for M.2, but allow for that experience to be gained outside of the 10 year window. We would like to suggest amending R.3 to the following:

"Experience in automated test script development over and above the requirements of M.3.

Scoring

6 to 8 years: 5 points

8+ years to 11 years: 15 points

More than 11 years: 20 points

****Experience for this criterion may be demonstrated outside of the last 10 years"***
