PART 1 - GENERAL INFORMATION

1. Introduction

The bid solicitation and resulting contract document is divided into seven parts plus annexes as follows:

Part 1 General Information: provides a general description of the requirement;

Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation and states that the Bidder agrees to be bound by the clauses and conditions contained in all parts of the bid solicitation;

3. Summary

Description and requirement

The purpose of this Request for Proposal (RFP) is to solicit bids from interested Canadian organizations to provide TQF floor repairs projects at the David Florida Laboratory (DFL) in Ottawa.

Interested bidders are required to submit their proposals in accordance with the instructions provided in this RFP. A description of the work to be completed under this requirement is provided in the Statement of Work attached hereto as **Appendix A** and drawings and specifications at **Appendix C**.

4. Communications Notification

As a courtesy, the Government of Canada requests that successful bidders notify the Contracting Authority in advance of their intention to make public an announcement related to the award of a contract.

5. Debriefings

After contract award, bidders may request a debriefing on the results of the bid solicitation. Bidders should make the request to the Contracting Authority within 15 working days of receipt of notification that their bid was unsuccessful. The debriefing may be provided in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority (<u>Claudine.morin@asccsa.gc.ca</u>) no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient

detail in order to enable government of Canada to provide an accurate answer. Technical enquiries that are of a "proprietary" nature must be clearly marked "proprietary" at each relevant item. Items identified as proprietary will be treated as such except where government of Canada determines that the enquiry is not of a proprietary nature. Government of Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by government of Canada.

4. Bid Validity Period

Bids will remain open for acceptance for a period of not less than thirty (30) days from the closing date of the bid solicitation, unless specified otherwise in the bid solicitation. Government of Canada reserves the right to seek an extension of the bid validity period from all responsive bidders in writing, within a minimum of three (3) days before the end of the bid validity period. If the extension is accepted by all responsive bidders, Government of Canada will continue with the evaluation of the bids. If the extension is not accepted by all responsive bidders, government of Canada will, at its sole discretion, either continue with the evaluation of the bids of those who have accepted the extension or cancel the solicitation.

5. Optional Site Visit but highly recommended

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for a tour of the work site. **The site visit will be held on June 09, 2014, at 10:00am at David Florida Laboratory (3701 Carling Avenue, Ottawa, Ontario, K2H 8S2).** Bidders are requested to communicate with the Contracting Authority one (1) day before the scheduled visit to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance form. Bidders who do not attend or send a representative will not be given an alternative appointment but they will not be precluded from Submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

- * For the site visit, it is recommended bringing the request for proposals documentation with you to be able to take notes.

6. Negotiations

In the event that the lowest compliant bid exceeds the amount of funding government of Canada has allocated for the construction phase of the work

- (a) by 15% or less, government of Canada, at its sole discretion, shall either
 - (i) cancel the solicitation; or
 - (ii) obtain additional funding and, subject to the provisions of GI11 of the General Instructions to Bidders, award the Contract to the Bidder submitting the lowest compliant bid: or
 - (iii) revise the scope of the work accordingly and negotiate, with the Bidder submitting the lowest compliant bid, a corresponding reduction in its bid price.
- (b) by more than 15%, government of Canada, at its sole discretion, shall either
 - (i) cancel the solicitation; or
 - (ii) obtain additional funding and, subject to the provisions of GI11 of the General Instructions to Bidders, award the Contract to the Bidder submitting the lowest compliant bid; or
 - (iii) revise the scope of the work accordingly and invite those who submitted

compliant bids at the original invitation to tender to re-bid the work.

If negotiations or a re-bid are undertaken as is contemplated in subparagraphs 1)(a)(iii) or 1)(b)(iii) above, Bidders shall retain the same subcontractors and suppliers as they carried in their original bids.

If government of Canada elects to negotiate a reduction in the bid price as is contemplated in subparagraph 1)(a)(iii) herein and the negotiations fail to reach an agreement, government of Canada shall then exercise either of the options referred to subparagraphs 1)(a)(i) or 1)(a)(ii).

7. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in the Province of Ontario. Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

STATEMENT OF WORK

Project Intent:

To repair deficiencies & provide additional supports to TQF ground level flooring to achieve 250 psf Live Load.

Project Requirements:

Provide all necessary labour, materials, lifts and equipment required to complete the structural repairs at all three areas as per drawings S1.

Provide all necessary labour, materials, lifts and equipment required for the following architectural work related to the above structural repairs:

a. General requirements:

 Protect all equipment, services, flooring, walls, ceilings ... etc at all repair areas; use heavy duty 6mil polyethylene followed by masonite / plywood hardboard for maximum protection from falling objects.

b. Area 1:

- Protect all services & equipment from welding work.
- Paint repaired area, finish / color / type to match existing steel.

c. Area 2:

- Protect all services & equipment from welding work.
- Protect shaker, steel floor plates, crane & all room equipment & finishes at all times.
- Crane not to be used during construction. Contractor to provide lifting equipment as required, confirm with project manager for floor steel plates loading.
- Remove drywall as needed to expose main beam, reinstate after completion of welding & inspection, patch & paint to match existing.
- Paint new HSS beams & connections, finish / color / type to match existing ceiling.

d. Area 3:

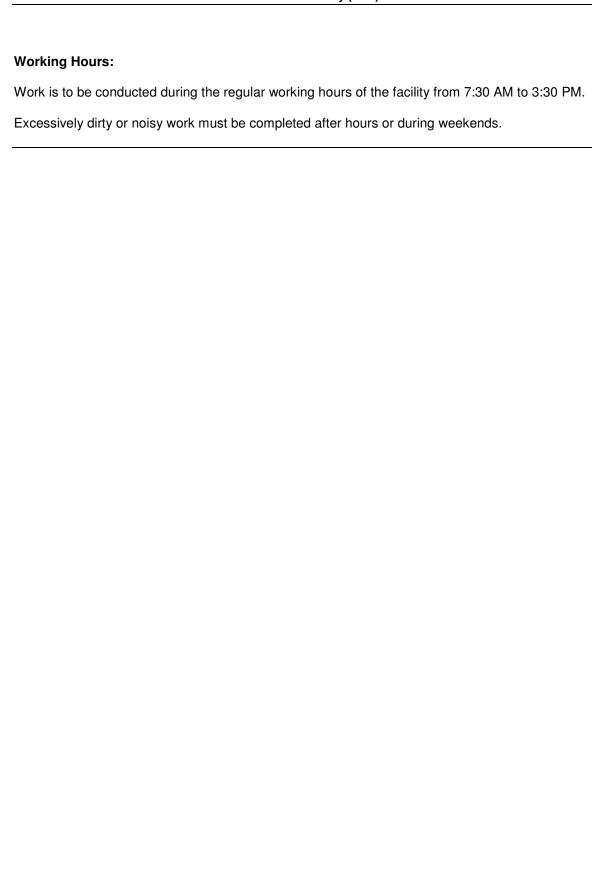
- Protect all adjacent services & equipment from slab work.
- Protect all services below in basement level.
- Slab to be saw cut, no jack hammering is allowed. Use hepa filter vacuum at all times to protect bay environment. Wet saw cut is preferred as long as services below will be protected.
- Provide & install VCT flooring tiles on new slab when completely set, color to match existing.
- Patch, finish & paint underside of steel deck at basement ceiling to match ceiling color

Provide stamped shop drawings for structural engineer review before starting construction work.

Remove all construction waste & debris on daily basis, use of CSA waste bins is not allowed. Upon completion, remove all protective materials & carry-on a high level cleaning to all areas including wiping down all services, equipment, walls, floors, ceiling ... etc.
