Questions:

Q6: On page 7 of 47 of Terms of Reference, we are limited to 24 pages TOTAL for C.V.'s. We read this as 3 per specialty, regardless of how many geographies we are proposing for. To put it another way it is not 3 per specialty per geography. Is our assumption correct on this?

A5: Yes. The page limitation is dependent on the number of speciality services regardless of the geographical region(s) proposed.

Q7: On page 7 under Key Personnel Experience and Expertise, it is indicated that “three 1-page curriculum vitae, one for each of the 3 proposed key personnel for each service” is to be included. On page 13, under R3, it is indicated that we are to “provide expertise/experience information for at least 3 key personnel for each of the speciality services for which the supplier wishes to qualify”. Please confirm if we may submit more than 3 resumes per speciality.

A7: It was our intent to limit the proposed key personnel to three individuals per speciality service.

At Attachment 1, R3 Key Personnel Expertise and Experience, 1. What we are looking for:

Delete: *Please provide expertise/experience information for at least 3 key personnel for each of the Speciality Services for which the supplier wishes to qualify.*

Insert: *Please provide expertise/experience information for three key personnel for each of the Speciality Services for which the supplier wishes to qualify.*
