## **Amendment 001 – Tree Trimming & Disposal**

**Questions from bidders with response back from Public Works and Government Services Canada.**

**Q1.** I was speaking with you on the phone yesterday and I was hoping to arrange a site meeting to go over an idea of the work involved contract # WO125-14K275A.

**A1.** Individuals are permitted to drive around the majority of the base. Any areas that are closed from public access will have either gates manned by security personnel, or the gates will be closed and locked. There are trees throughout the majority of the base, and many in the military housing area (PMQs) that have become dangerous due to their size and age. There is also a need to have areas of our perimeter fence lines cleared from time to time. Bidders are welcome to drive perimeter roads, such as Whites road east of the base, to have an idea of the scope involved.

CFB Trenton and CFD Mountain View both have the typical array of trees indigenous to this area.

**Amendment 001 is also being raised to amend the Pricing Tables to accurately reflect usages for each year.**
