Extension of Bid Period

Bidders were made aware of the context of the Value Proposition requirements and consulted in advance prior to the formal amendment to include such requirements.

An extension from 30th May to 3rd July 2014 was provided following the introduction of the Value Proposition and Industry Consultation, in light of the impact of the new requirement and resulting need to address questions from bidders, which potentially reduced Bidder proposal preparation time.

Since Canada wants to encourage competition and receive multiple proposals, a second bid period extension is advisable and justifiable, particularly since multiple potential bidders have submitted extension requests.

While an extension is warranted, the length of the extension could have significant cost and time implications to Canada. Although it is not the maximum time requested by all potential bidders, Canada has determined that a further two and a half month extension is the longest extension possible without substantial, negative Cost and Schedule implications to the program. Thus, the Solicitation closing date is changed from July 3rd to September 16, 2014.
