Question #43:

At Annex A - Requirement

Group 1

Section 4.6 Hardware and Accessories

4.6.2 Door and drawer pulls MUST be cast architectural bronze octagonal knob, nominal 28 mm (1 1/8") diameter by 25 mm (1") high.

4.6.2.1 Finish MUST be dark oxidized satin bronze, oil rubbed, finish code 613 to CAN/CGSB-69.34-M90, Materials and Finishes.

Lee Valley does not offer custom finishing on their pulls. Please confirm that the client requires that we purchase pulls and then have them re-finished in the satin bronze colour.

Answer #43:

The requirement has been revised as follows:

At Annex A - Requirement

Group 1

Section 4.6 Hardware and Accessories

Delete:

4.6.2 Door and drawer pulls MUST be cast architectural bronze octagonal knob, nominal 28 mm (1 1/8") diameter by 25 mm (1") high.

Insert:

4.6.2 Door and drawer pulls MUST be cast architectural brass octagonal knob, nominal 28 mm (1 1/8") diameter by 25 mm (1") high.

Yes, the manufacturer is required to re-finish the pulls as per 4.6.2.1. The finish is a patina that is added by the manufacturer to the pull.

Question #44:

At Appendix A.1 Technical Evaluation Criteria for Group 1, 2 & 3 it is stated to supply ".....corner detail 6" x 6" x sufficient height to demonstrate the entire corner"

Does it mean to supply 3D corner of the desk, credenza etc. which will include 6 x6 top with a part of attached modesty panel and side gable, or is it just the corner of top / worksurface, showing the whole detail (profile).

Answer #44:

The Samples required are specified as such as we are looking for the details of the mitered corner joints to be included. The entire edge or base detail is to be provided so the profile and workmanship can be evaluated.

Question #45:

At Annex A - Specification,
4.2 Hardwood Veneer

This section should describe clearly what veneer cut (flat or quarter) and veneer matching (book match, or slip match) is to be used.

- In 4.2.3 - All veneer Must be book matched..... for horizontal surfaces and for all vertical planes (which may be made up of surfaces such as doors, gables, end panels, modesty panels, drawer fronts, pedestal backs and computer table backs) - book match is used with flat cut veneers.

Does it mean that doors, gables, end panels are all flat cut? - If so it is contradicting with the next paragraph;

- 4.2.4 Veneer for exposed parts (visible surfaces of furniture with doors and drawers closed, modesty panels, end & back) Must be quarter cut black walnut species. Quarter cut veneer is usually slip matched not book matched as noted in 4.2.3.

It needs to be clearly stated where the quarter cut veneer is to be used.

Answer #45:

The veneer cut is specifically mentioned in sections 4.2 for Groups 1, 2, 3, 4. Book or slip matching is acceptable for quarter cut materials. Book matching is acceptable for flat cut materials.

Question #46:

At Annex A - Specification ,5.1.12 Each file drawer MUST be provided with letter and legal hanging-file rail system...

Filing rails (PVC) are pre-installed on the drawer parameters. Currently our drawers are 16" deep, that allows for filing letter (front to back) and legal (side to side) without additional bars. Please confirm that this method is acceptable.

Answer #46:

The specified drawer construction is such that it will accommodate more than files, either letter or legal. By producing drawers with pre- installed hanging rails the drawer size is reduced. This is not what we are expecting.

Question #47:

Can the Solicitation Closing Date be extended? This time is required to fabricate the mandatory samples identified in Appendix i - Technical Evaluation Criteria.

Answer #47:

Yes. The Solicitation closing date has been amended. Refer to the front page of the Request for Proposal.

Question #48:
