### Line1, Tailoring Services

The Department of National Defense (DND), Canadian Forces Base (CFB) Moose Jaw, 15 Wing Supply, Moose Jaw, Saskatchewan requires a contractor to provide Tailoring Services for Canadian Forces uniforms/equipment including sewing on insignias, ranks, crests, alterations, manufacture and/or repairs.

The contractor will also provide a qualified worker on site at 15 Wing Clothing Stores for onsite services/ clothing parade each Tuesday and Thursday from 930AM to 1130AM.
