**Questions and Answers are provided in reference to the specifications for clarification.**

**Q11.** The design details described for the remediation of metal impacted soils, ore concentrate and waste rock at the Main Showing in Section 31 22 15 - Grading does not match the detail provided in Drawing C16. Specifically the specification calls for the placement of metal impacted soils first, then ore concentrate over the soil and then waste rock. Section A-A on Drawing C16 indicates that ore material and waste rock are to be placed first, followed by impacted soil. Section C-C for Trench #2 leads to further confusion as it shows ore impacted soil to be placed first and then impacted soil and waste rock. The name descriptions are not consistent between the two sections.

We will need to know if we should follow the methodology described within the specification or the drawing. If the ore concentrate is to be placed between the metal impacted soil and waste rock as described in Section 31 22 15, we will need to better understand the estimated quantity of ore material and how easily it can be separated from the other materials.

**A11.** Priority is given to ore concentrate and impacted soil followed by waste rock.

**Q12.** Is there any ore concentrate and metal impacted soil at the West Showing at Copper Pass that needs to be excavated and disposed of into the trenches at the Main Showing? Section 31 22 15 of the specification indicates that localized pockets are to be recovered and containerized. The Summary of Environmental Impacts in Appendix A of the specification indicates that no remediation work is required at the West Showing. Please confirm if this soil and ore relocation work is necessary and if so, what is the estimated quantity of material to be relocated?

**A12.** There are two blooms of ore rich rock at the West Showing that would both fit into a 20 L pail. The Departmental Representative would show them the two blooms to be collected and relocated to the Main Showing for disposal.
