INSURANCE TERMS

The Certificate of Insurance and its instructions has been replaced see Annex B. (Completed certificate is NOT required at bid closing).

R2940D CLAUSE IS CANCELLED AND SECTION 3.8 OF R2830D IS MODIFIED

Following the repeal of the *Fair Wages and Hours of Labour Act*, R2940D clause is canceled for contracts awarded after January 1, 2014. For contracts awarded prior to that date the clause remains applicable.

The "Code of Conduct" is replaced with "Integrity Provision" and some modifications to the clause where done. See GI01 of R2710T.

SUPPORT THE USE OF APPRENTICES

SI01 INTEGRITY PROVISIONS - ASSOCIATED INFORMATION

By submitting a bid, the Bidder certifies that the Bidder and its Affiliates are in compliance with the provisions as stated in Section 01 Integrity Provisions - Bid of General Instructions – Construction Services – Bid Security Requirements, R2710T. The associated information required within the Integrity Provisions will assist Canada in confirming that the certifications are true.

SI03 ENQUIRIES DURING THE SOLICITATION PERIOD

1. Enquiries regarding this bid must be submitted in writing to the Contracting Officer named on the Invitation to Tender - Page 1 as early as possible within the solicitation period. Except for the approval of alternative materials as described in G115 of R2710T, enquiries should be received no later than seven (7) calendar days prior to the date set for solicitation closing to allow sufficient time to provide a response. Enquiries received after that time may not result in an answer being provided.
2. To ensure consistency and quality of the information provided to Bidders, the Contracting Officer shall examine the content of the enquiry and shall decide whether or not to issue an amendment.
3. All enquiries and other communications related to this bid sent throughout the solicitation period are to be directed ONLY to the Contracting Officer named on the Invitation to Tender - Page 1. Failure to comply with this requirement may result in the bid being declared non-responsive.

SI04 OPTIONAL SITE VISIT

SI05 REVISION OF BID

A bid may be revised by letter or facsimile in accordance with GI10 of R2710T. The facsimile number for receipt of revisions is (819) 956-1459.

SI06 BID RESULTS

1. A public bid opening will be held in the office designated on the Front Page "Invitation to Tender" for the receipt of bids shortly after the time set for solicitation closing.
2. Following solicitation closing, bid results may be obtained by faxing at No. (819) 956-1459.

SI07 INSUFFICIENT FUNDING

In the event that the lowest compliant bid exceeds the amount of funding allocated for the Work, Canada in its sole discretion may

- a. cancel the solicitation; or
- b. obtain additional funding and award the Contract to the Bidder submitting the lowest compliant bid; and/or
- c. negotiate a reduction in the bid price and/or scope of work of not more than 15% with the Bidder submitting the lowest compliant bid. Should an agreement satisfactory to Canada not be reached, Canada shall exercise option (a) or (b).

SI08 BID VALIDITY PERIOD

1. Canada reserves the right to seek an extension to the bid validity period prescribed in BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders shall have the option to either accept or reject the proposed extension.
2. If the extension referred to in paragraph 1. of SI08 is accepted, in writing, by all those who submitted bids, then Canada shall continue immediately with the evaluation of the bids and its approvals processes.
3. If the extension referred to in paragraph 1. of SI08 is not accepted in writing by all those who submitted bids then Canada shall, at its sole discretion, either
 - a. continue to evaluate the bids of those who have accepted the proposed extension and seek the necessary approvals; or
 - b. cancel the invitation to tender.
4. The provisions expressed herein do not in any manner limit Canada's rights in law or under GI11 of R2710T.

SI09 SECURITY RELATED REQUIREMENTS

1. **At bid closing, the Bidder must hold a valid** Security Clearance as indicated in section SC01 of the Supplementary Conditions. Failure to comply with this requirement will render the Bid non-compliant and no further consideration will be given to the Bid.
2. The Successful Bidder's personnel, as well as any subcontractor and its personnel, who are required to perform any part of the work pursuant to the subsequent contract must meet the mandatory security requirement as indicated in section SC01 of the Supplementary Conditions. **Individuals who do not have the required level of security will not be allowed on site.** It is the responsibility of the successful bidder to ensure that the security requirements are met throughout the performance of the contract. Canada will not be held liable or accountable for any delays or additional costs associated with the successful bidder's non-compliance with the mandatory security requirement.

SI10 PUBLIC WORKS AND GOVERNMENT SERVICES CANADA AND DEFENCE CONSTRUCTION CANADA APPRENTICE PROCUREMENT INITIATIVE

1. To encourage employers to participate in apprenticeship training, Contractors bidding on construction and maintenance contracts by Public Works and Government Services Canada (PWGSC) are being asked to sign a voluntary certification, signaling their commitment to hire and train apprentices.
2. Canada is facing skills shortages across various sectors and regions, especially in the skilled trades. Equipping Canadians with skills and training is a shared responsibility. In Economic Action Plan (EAP) 2013, the Government of Canada made a commitment to support the use of apprentices in federal construction and maintenance contracts. Contractors have an important role in supporting apprentices through hiring and training and are encouraged to certify that they are providing opportunities to apprentices as part of doing business with the Government of Canada.
3. Through the Economic Action Plan 2013 and support for training programs, the Government of Canada is encouraging apprenticeships and careers in the skilled trades. In addition, the government offers a tax credit to employers to encourage them to hire apprentices. 5. The Contractor hereby certifies the following:

In order to help meet demand for skilled trades people, the Contractor agrees to use, and require its subcontractors to use, reasonable commercial efforts to hire and train registered apprentices,

to strive to fully utilize allowable apprenticeship ratios and to respect any hiring requirements prescribed by provincial or territorial statutes

The Contractor hereby consents to this information being collected and held by PWGSC, and Employment and Social Development Canada to support work to gather data on the hiring and training of apprentices in federal construction and maintenance contracts.

To support this initiative, a voluntary certification signaling the Contractor's commitment to hire and train apprentices is available at Appendix 3.

SUPPLEMENTARY CONDITIONS (SC)

SC01 SECURITY REQUIREMENTS

1. The Contractor/Offeror must, at all times during the performance of the Contract/Standing Offer, hold a valid **Designated Organization Screening (DOS)**, issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC).
2. The Contractor/Offeror personnel requiring access to sensitive work site(s) must **EACH** hold a valid **RELIABILITY STATUS**, granted or approved by CISD/PWGSC. Until the security screening of the Contractor personnel required by this Contract has been completed satisfactorily by the CISD, PWGSC, the Contractor personnel **MAY NOT ENTER** sites without **an escort**.
3. Subcontracts which contain security requirements are **NOT** to be awarded without the prior written permission of CISD/PWGSC.
4. The Contractor/Offeror must comply with the provisions of the:
 - a. Security Requirements Check List and security guide (if applicable), attached at Annex A.
 - b. Industrial Security Manual (Latest Edition).

SC02 LIMITATION OF LIABILITY

GC1.6 of R2810D is deleted and replaced with the following:

GC1.6 Indemnification by the Contractor

1. The Contractor shall indemnify and save Canada harmless from and against all claims, demands, losses, costs, damages, actions, suits, or proceedings whether in respect to losses suffered by Canada or in respect of claims by any third party, brought or prosecuted and in any manner based upon, arising out of, related to, occasioned by, or attributable to the activities of the Contractor in performing the Work, provided such claims are caused by the negligent or deliberate acts or omissions of the Contractor, or those for whom it is responsible at law.
2. The Contractor's obligation to indemnify Canada for losses related to first party liability shall be limited to:
 - a. In respect to each loss for which insurance is to be provided pursuant to the insurance requirements of the Contract, the Commercial General Liability insurance limit for one occurrence as referred to in the insurance requirements of the Contract .
 - b. In respect to losses for which insurance is not required to be provided in accordance with the insurance requirements of the Contract, the greater of the Contract Amount or \$5,000,000, but in no event shall the sum be greater than \$20,000,000.

The limitation of this obligation shall be exclusive of interest and all legal costs and shall not apply to any infringement of intellectual property rights or any breach of warranty obligations.
3. The Contractor's obligation to indemnify Canada for losses related to third party liability shall have no limitation and shall include the complete costs of defending any legal action by a third party. If requested by Canada, the Contractor shall defend Canada against any third party claims.

4. The Contractor shall pay all royalties and patent fees required for the performance of the Contract and, at the Contractor's expense, shall defend all claims, actions or proceedings against Canada charging or claiming that the Work or any part thereof provided or furnished by the Contractor to Canada infringes any patent, industrial design, copyright trademark, trade secret or other proprietary right enforceable in Canada.
5. Notice in writing of a claim shall be given within a reasonable time after the facts, upon which such claim is based, became known.

SC03 INSURANCE TERMS

1. Insurance Contracts

- a. The Contractor must, at the Contractor's expense, obtain and maintain insurance contracts in accordance with the requirements of the Certificate of Insurance. Coverage must be placed with an Insurer licensed to carry out business in Canada.
- b. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract. The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

2. Period of Insurance

- a. The policies required in the Certificate of Insurance must be in force from the date of contract award and be maintained throughout the duration of the Contract.
- b. The Contractor must be responsible to provide and maintain coverage for Products/Completed Operations hazards on its Commercial General Liability insurance policy, for a period of six (6) years beyond the date of the Certificate of Substantial Performance.

3. Proof of Insurance

- a. Before commencement of the Work, and no later than thirty (30) days after acceptance of its bid, the Contractor must deposit with Canada a Certificate of Insurance on the form attached herein.
- b. Upon request by Canada, the Contractor must provide originals or certified true copies of all contracts of insurance maintained by the Contractor pursuant to the Certificate of Insurance.

4. Insurance Proceeds

In the event of a claim, the Contractor must, without delay, do such things and execute such documents as are necessary to effect payment of the proceeds.

5. Deductible

The payment of monies up to the deductible amount made in satisfaction of a claim must be borne by the Contractor.

APPENDIX 1 MAINTENANCE SPECIFICATION

Division 1 Terms

Division 1 of the technical specification applies to the entirety of this contract, including 'Maintenance Specification', for the entirety of the contract, and until final completion of the work has been achieved.

Index:

1. Cleaning Operations
2. Staffing
3. Materials and Equipment
4. Attendance Log Book
5. Service Requests
6. Operations and Frequencies – Overhead Protection Roofs and related components
7. Block Plan – Refer to Block Plan Drawing S001 for Overhead Protection to be cleared.

1. Cleaning Operations

- .1 The Contractor shall supply and outlay all essential labour, supervision, transportation, storage, necessary material, and apparatus to carry out the snow and ice removal from all overhead protection roof areas, and all other roofing elements such as, but not limited to: roofs, perimeter access, emergency access, catch screens, snow guards, eaves, canopies, ledges, catwalks, railings, and parapets.
- .2 All snow and ice removed from the overhead protection roofs and roofing components under the contract, must be disposed off the site. The Contractor will leave all building ground perimeters such as: entrances, fire routes, sidewalks, areas below overhead protection, driveways, landscaped areas, and alleys, completely clear of snow and ice during, and at the end of each shift.
- .3 Remove overhanging snow drifting that extends beyond overhead protection roof edge, when it is noted in the daily inspections.
- .4 The Technical Authority will direct the snow and ice removal priority of the Contractors' crew, as required at his or her discretion.
- .5 The Contractor will be held responsible for any damage to persons or property, whether Canada's or others, caused directly or indirectly through work period.
- .6 If at any time during the period of the contract, the Contractor deems it necessary to use a bosun's chair or swing-stage, the Contractor must advise the Technical Authority in writing, and provide a copy of the engineer's certificate for the use of the bosun's chair and / or swing stage prior to the commencement of the work. Before using any suspended equipment, the Contractor is responsible to verify that maintenance and/or inspection logs indicate that the systems were maintained and inspected. If those reports are not available, the Contractor must notify the Technical Authority.
- .7 Protect existing wall mounted building security cameras from damage during snow removals.

2. Staffing

- .1 All staff employed by the Contractor in relation with this service agreement must have a 'Reliability' security clearance.
- .2 Employees must be at least 18 years of age.

3. Materials and Equipment

- .1 The Contractor will ensure that all equipment used to carry out the service is in good condition. The Technical Authority reserves the right to have equipment judged to be unsafe, not suitable, or defective, and immediately taken out of service. The Contractor is responsible to supply (without any delays) suitable replacement equipment.

- .2 Equipment provided by the Contractor for use under the contract will consist of but not be limited to: telescopic boom and /or over-centre bucket truck, swing-stage or bosun's chair, soft brooms, push broom, plastic shovels, telescopic poles, steam machine, industrial heavy duty ladders, and other miscellaneous safety equipment as required. Use of axes and sledgehammers are prohibited under the terms of the contract, and may lead to termination and / or other remedies.
- .3 The Contractor will supply and install at *their* own expense, pedestrian safety barriers and 'both side bilingual signs', surrounding the building's perimeter, in order to secure and alert pedestrians of possible snow and falling ice.
- .4 Mechanized and motorized equipment (such as snow blowers), is not permitted on the overhead protection roof. However, mechanized and motorized (telescopic boom and /or over center bucket truck), may be used at ground level for removal of snow from site. Contractor to provide competent certified operators for ground level motorized equipment operation.
- .5 The Contractor must use a steam machine, approved by the Technical Authority, and capable of providing heat no less than 93.3°C.
- .6 When required, the Contractor will supply and spread at *their* own expense a 'non-corrosive / environmentally friendly' product to help melt the ice in work areas.
- .7 No storage space will be assigned to the Contractor for *their* materials and equipment.

4. Attendance Log Book

- .1 Each time that the Contractor receives a 'call-up' to perform snow and ice removal from roofs and eaves, *they are* to sign in and out using the 'Attendance Log Book', for each building where *they have* provided the service. The 'Attendance Log Book' must be utilized by the supplier - hours will be verified for payment.

5. Service Requests

- .1 When the Contractor receives a service request from National Service Call Center (NSCC), they will be on site within a six (6) hour limit.
- .2 Once the service call is concluded, the Contractor must then call NSCC at 800.463.1850, to close the service request.
- .3 Should the Contractor not be able to conclude and close the service call-up, for any given reason, they must communicate with NSCC to relate the reasons for the non-completion, and to assure follow-up until closure of service request.
- .4 The Contractor will not refuse any service request by the Technical Authority, or its representative, and will be on site within six (6) hours of the service request. The Contractor must respond on-site within 1 hour, in an 'emergency' situation.

6. **Operations and Frequencies – Overhead Protection Roofs, and Related Components**
- .1 All surfaces and areas mentioned in Section 1.1 shall be cleared of snow & ice.
 - .2 Removal of ice build-up must only be accomplished with a steam machine.
 - .3 The Contractor will provide snow and ice removal services on an as required 24/7 basis.
7. **Block Plan**
- .1 Refer to drawing S001 for extent of LTDLC overhead protection, blocks 100S, 100N, 200, and 300 to have ice and snow removed. Overhead protection roof areas are shown shaded on drawing S001.

ANNEX C - VOLUNTARY REPORT FOR APPRENTICES EMPLOYED DURING THE CONTRACT (Sample)

(This report is not required at solicitation closing)

The Contractor should compile and maintain records on the number of apprentices and their trade that were hired to work on the contract.

The Contractor should provide this data in accordance with the format below. If no apprentices were hired during the contract period, the Contractor should still provide a "nil" report.

The data should be submitted six months after the Contract award or at the end of the Contract, whichever comes first to the Contracting Authority.
