**Amendment 002 is raised for the following:**

**Question from suppliers and answers from Canada.**

1. **REFER:** Annex B, Basis of Payment, Line item 2, Lamb Loin Chops, minimum of 250 gm to a maximum of 240 gm each, prepared from a single loin with the flank.

**QUESTION:** Please review the range of sizing. This is not possible to achieve.

**ANSWER:** Annex B, Basis of Payment, Line item 2, Lamb Loin Chops, minimum of 240 gm to a maximum of 250 gm each, prepared from a single loin with the flank.
