Q1: Who do we coordinate with the gain pre-bid site access to the LTF?

A1: To arrange a site tour please contact Frank Close for permission to view the land-farm treatment facility.

Q2: I understand there is currently 2,500 m3 of treated soil in LTF 1 and 2 and that this soil will need to be transferred to the 'Bioremediated Soil Storage Area'. Is that correct?

A2: The assumed work flow was to treat the 2,500 m3 of soil from LTF's 1 and 2. Upon receipt of authorization from Yukon Environmental each 0.45m lift of treated soil would be removed and transported to the 'Bioremediated Soil Storage Area'.

Q3: I understand there is currently soil in LTF 3 that requires bioremediation. Is this soil to be bioremediated within LTF 3? If so, then are we adding fertilizer to the sump water in LTF 1 & 2 for any particular reason? Or would we need to transfer the soil from LTF 3 to LTF 1 and 2 for treatment?

A3: Since sufficient volume of soil requiring treatment is present in LTF 1 and 2 we do not anticipate a requirement to treat or transfer the soil in LTF 3.
