This Amendment 001 is raised to provide clarification to questions received from prospective bidders and to correct the "Tender Closing Date & Time" on Page 2 of the original Solicitation Document.

All other terms and conditions remain unchanged.

Q1: Is there an office facility available for use at each site?

A1: If the contractor deems it is required they will have to provide their own facilities for a site office as part of the contract.

Q2: What is the anticipated wait time for samples of treated soils before a lift can be removed & the next layer of treatment commences?

A2: Wait times for sample results and approval from the Yukon Environment vary from 3 to 10 days.

Q3: Is the waiting period for sample results considered standby?

A3: Adequate space exists to allow for treatment of one portion while a second portion is being sampled, tested and awaiting for permission to remove the soil. The contractor is expected to sequence the work to allow for continuous treatment and soil stripping while providing a reasonable time for the consultant to complete the sampling, testing and receiving permission to remove the treated soil. If the contractor feels that additional costs related to standby or rescheduling may be incurred, they must contact PWGSC prior to incurring any additional standby or other costs, identify the issue and await further instructions from PWGSC.

Q4: Will other contractors be working in this area?

A4: There is no scheduled work for a second contractor but there is a potential that a second contractor may be loading contaminated soil into the facility while treatment is occurring and the soil treatment contractor is expected to accommodate soil loading.
