This solicitation amendment number one (01) is issued to answer questions received during the solicitation process.

Question: Please confirm whether the contractor is allowed to stay on site while constructing the Ferryway and if so whether the contractor has the use of the parks facilities while working on site or whether we will require our own camp facilities

Answer: The contractor must stay at the Rabbitkettle Lake cabin and use the associated facilities (food cache, washroom, etc.). Cabin location is approx 3 km from site. There will be a park staff member with them to help with any facility questions or issues. Maximum accommodation at the cabin is 6 pers. There are camping sites at the cabin location if more than 6 personnel need accommodation. The cabin is to be used as a cooking shelter by those choosing to camp.

Question: Please confirm whether the site supervisor can act as the Health and Safety coordinator or is this position required to be separate.

Answer: Site Supervisor can act as Health and Safety Coordinator.
