The solicitation amendment 001 is raised to answer bidders' questions:

Q1) It appears the RCMP is pursuing a very specific type of internet protocol software solution as per the requirements, would you entertain a similar affordable solution which would be fully integrated and provide the RCMP with the required system delay capabilities/results as an alternative?

A1) The solution proposed must meet the requirements in accordance with the RFP.

Q2) The RFP states there are 28 repeater sites. Would these sites have access to internet connectivity?

A2) No, these repeater sites do not have any internet connectivity.

Q3) You list an option for 40 extra units. Would these units be used for BC, or would they be allocated to other locations in Canada?

A3) This procurement is intended for BC only.

Q4) Is it possible for Company A to submit a bid, but then have the order go through Company B? How would one go about doing this?

A4) There are two options:

i.) Company A can prepare a bid on its own. If Company A wins, the contract would go to Company A. However, Company A could subcontract to Company B. In this case, RCMP would only deal directly with Company A for all issues and payment will go to Company A.

ii.) Company A could submit a bid by forming a joint venture with Company B. Please refer to RFP Standard Instructions-Goods or Services Competitive Requirements
