Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

## **4. Applicable Laws**

## **ANNEX "A"**

### **REQUIREMENT**

#### **BACKGROUND**

1. 4 Engineer Support Regiment (4 ESR) will be conducting Regimental level training in the 5 CDSB Gagetown Range and Training Area (GRTA). The training will be directly attributable to 4 ESR's assigned task, under the Canadian Army's (CA) Operating Plan, Chapter 3; Support Expeditionary Theatre Activation/Opening. Significant portions of this training will focus on the preparation of terrain, and the construction of a Forward Operating Base (FOB).

#### **OBJECTIVES**

2. The intent of this Statement of Requirement (SOR) is to define the requirements, the methods verification, and responsibilities for a civilian firm(s) to provide and deliver specific types of crushed rock and particulates to 4 ESR, during the months of September, October and November 2014.

#### **SCOPE OF REQUIREMENT**

3. The scope of work will require the contractor(s) to provide the following crushed rock and particulates to designated points within the CFB GRTA and 5CDSB Gagetown. The quantities and the conditions of the rock and particulate requirements are as follows:

- a. 3,840 tonnes of 0-75mm / 0-3" well graded crushed stone (rock) – material to be compliant with standards described in Section 201.2, Table 201-2, "Grading Limits – Cover Material" for 19 mm, of the New Brunswick Department of Transportation Standard Specifications, 2011. Delivered to AS3 (GL 162 736).
  - (1) An additional 3,840 tonnes of 0-75mm / 0-3" well graded crushed stone (rock) – material to be compliant with standards described in Section 201.2, Table 201-2, "Grading Limits – Cover Material" for 19 mm, of the New Brunswick Department of Transportation Standard Specifications, 2011. The decision as to whether or not to utilise the option to procure the additional material will be exercised by 4 Engineer Support Regiment no later than 28 October 2014, with the additional material to be delivered to AS3 (GL 162 736) by 5 November 2014.
- b. 1,920 tonnes of 0-37.5mm / 0-1<sup>1</sup>/<sub>4</sub>" well graded crushed stone (rock) – material to be compliant with standards described in Section 201.2, Table 201-2, "Grading Limits – Cover Material" for 19mm, of the New

Brunswick Department of Transportation Standard Specifications, 2011.  
Delivered to AS3 (GL 162 736).

- (1) An additional 1,920 tonnes of 0-37.5mm / 0-1<sup>1</sup>/<sub>4</sub>" well graded crushed stone (rock) – material to be compliant with standards described in Section 201.2, Table 201-2, “Grading Limits – Cover Material” for 19 mm, of the New Brunswick Department of Transportation Standard Specifications, 2011. The decision as to whether or not to utilise the option to procure the additional material will be exercised by 4 Engineer Support Regiment no later than 28 October 2014, with the additional material to be delivered to AS3 (GL 162 736) by 5 November 2014.
- c. 120 tonnes of 0-20mm / 0-3/4" well graded crushed stone (rock) – material to be compliant with standards described in Section 201.2, Table 201-7, “Grading Limits – Cover Material” for 19mm, of the New Brunswick Department of Transportation Standard Specifications, 2011. Delivered to AS3 (GL 162 736) by 5 November 2014.
- d. 200 tonnes of R-5 Riprap – material to be compliant with standards described in Section 608.1, Table 608-1, “Random Riprap Grading Limits” for R-5 Riprap, of the New Brunswick Department of Transportation Standard Specifications, 2011. Delivered to AS3 (GL 162 736).
- e. 42 tonnes of fine sand (levelling sand) – material to be compliant with standards described in Section 142 Table 142-1, “Grading Requirements for Levelling Sand” of the New Brunswick Department of Transportation Standard Specifications, 2011. 14 tonnes delivered to K 75 (FL 980 784) and 28 tonnes delivered to AS1 (GL 097 791).
- f. Delivery of materials shall commence by 22 September 2014, and all material shall be delivered by 17 October 2014. All deliveries will be conducted on weekdays between the hours of 08:00 and 18:00 hours, with no delivery arriving on location after 18:00 hours on any given day.
- g. Priority of delivery is, in listed order, 3” minus crushed stone, 1 1/4 minus crushed stone, R-5, 3/4 minus crushed stone and Sand.
- h. Prior to delivery the contractor(s) will be provided a point of contact that will meet them on location and direct them to the exact delivery location(s). Specific routes into the delivery location will be confirmed prior to delivery by 4 ESR, in order to prevent potential unsafe travel by any civilian vehicles within the Gagetown Range and Training Area.

4. The Project Authority for this requirement is:

## **CONCEPT OF DELIVERY**

5. This requirement is time specific, having a start date of no later than 22 September 2014 and an end date of 17 October 2014. All materials shall be delivered by 17 October 2014, so that the proper method of payment may be initiated. Proper procurement guidelines will be followed to ensure that there are no contracting irregularities.

6. Prior to the contract being awarded, all bidders shall provide a sample of each class of material they would provide should they be awarded the contract. Samples must be received by 4 ESR no later than 10 September 2014 to the project authority, for independent review by the Canadian Forces School of Military Engineering Soils Lab. Samples must be delivered in accordance with the following standards:

- (1) Each sample must indicate the full range of particulate/rock sizes expected to be present in each class of required material;
- (2) Samples shall be labelled by type, source, and providing firm; and,
- (3) There is no minimum size for a sample; however, maximum sample size will be restricted to 50 kilograms so as to facilitate ease of delivery.
