Answer #06:

The back foam is 1 ¼" thick (31.35mm) and the seat foam is 3 ½" thick (88.7mm).

Question #07:

At Annex A - Requirement, Group 2, Section 4.10 Multi-Media. Will the House of Commons be supplying the wire management?

Answer #07:

No - The wire management is to be supplied as an integral part of the assembly.

Question #08:

At Appendix i - Technical Evaluation Criteria, M14 Submission of Samples, 2. Two Seat Chair assembly. Can the Bidder supply a sample of the stain in Black Walnut and the frame and one leg connection in an alternate wood type as its construction sample?
