Question 4: We currently hold a RELIABILITY security status with the understanding that we can apply for security level of SECRET once awarded a contract with CANADA. Can you please confirm this is true and if not true can you clarify how to go from REALIBILITY status to SECRET?

Answer 4: This is not true; you must apply for SECRET status now. To register, you must contact the Industrial Security Program at <http://uat-iss-ssi.pwgs-c-tpsgc.gc.ca/index-eng.html>. Also, go to <http://www.tpsgc-pwgs-c.gc.ca/app-acq/lc-pl/lc-pl-eng.html> and scroll down to "Instructions for Bidders".

Question 5: My question was in regards to the Security Requirements for Bidders noted in the RFP. The information states that bidders who are not already registered with the Industrial Security Program should initiate the security screening process immediately. My question relates to the information requested, which includes 'address of bidder's office in Canada'. Our company does not have an office in Canada, so I wanted to clarify whether this is the process we need to complete or if there is some other requirement for US-based organizations?

Answer 5: Since your company does not have an office in Canada, you cannot register with the Industrial Security Program. To meet the Security Requirements of the RFP, you will have to obtain the equivalent security status within your federal government, and, should your company be the top-ranked bidder on the RFP, Canada would verify with your government that you have the equivalent security status to carry out the contract. Canada will not verify this information unless and until you are the winning bidder on the RFP.
