Question and Answers

The below Q and A's are in regards to **g.ix** on page 18 of Annex A - Statement of Work of the RFSO

1. The statement of work at **g.ix** states, " On each pocket shall be a smaller pocket located 2.5 inches from the top of the leg pocket and centred."

Question:

The small outside pocket has not been centered in the past. Do you want the pocket as indicated in the current SOW or as it has been done in the past?

Answer:

It was decided to centre the pocket this year

2. The statement of work at **g.ix** states, "The pocket must be at least 12.5 inches deep to accommodate wedge cap".

Question:

The pocket needs to be 14" long in order to hold the majority of the wedges that squadron members have. What is the depth of the pocket that you need, the 12.5 inches or the 14 inches?

Answer:

Most wedges are 12 inches; therefore that is why the statement reads must be at least 12.5 inches.
