Questions & Answers

Q1) Waste Disposal 1.11 .1 Says Disposal of surplus, unsuitable and waste materials says to remove outside the Park 1.2 Tender Bid Items .3 U1 Clear and Grubbing says to dispose of as directed by Departmental representative .4 U2 Stripping and Excavation .2 all materials to hauled to Niblock Pit.Where do we haul the clearing and grubbing material, old asphalt, gravel, topsoil, unsuitable materials? A1) Stripping materials and excavated soils (gravel, clay, soil) will go to Niblock pit. Clearing and grubbing (trees, brush, branches) will have to disposed outside the park. Asphalt, if any, will have to be disposed outside the park

Q2) Paving in the unit price table is in cubic meters in the Methods of measurement and basis of payment .7

U5 Asphalt Paving .1 U5 states payment is by the square meter

A2) Asphalt will be measured and paid by the m2. Please see the amended Unit Price Table
