This Solicitation Amendment is raised in order to:

(i) Answer the following questions:

Question 4: Due to the complexity of the requirements, the number of resources required to bid, and the large number of tier 2 RFP's currently on Buy and Sell, we respectfully request a 2 week extension in order to provide the Crown with a compliant and competitive bid.
