Amendment 003 has been raised to address questions being asked by potential bidders.

Question 1:

Are scissor lifts supplied by the RCMP?

Answer:

No. There are four locations that will require lifts to reach the smoke and/or heat detectors(Winnipeg Warehouse, Winnipeg vehicle storage, Winnipeg Hangar and Thompson Hagar. The Contractor must supply the scissor lift.

Question 2:

Is the Contract a la carte?

Answer:

No, it is a package deal.

Question 3:

Can we provide a count of both devices and emergency lighting?

Answer:

Yes, please see attached Question 3 - Attachment. These numbers are pulled from previous reports and are to be used for estimation purposes only. Device count includes manual alarm – initiating devices, automatic alarm – initiating devices, and audible and visual signaling devices. Contractor is responsible for verifying numbers and testing all devices on site.

Question 4:

Reference is made to a qualified Electrician, is a technician with a M License considered qualified?

Answer:

Any technician working on equipment must have appropriate licenses and insurance to work on the noted equipment.

Question 5:

The 20 extra trips to be included at a cost of 5 per year on the yearly cost?

Answer:

The twenty (20) trips are at any time over the term of the Contract.



Question 6:

Please also confirm that what is to be included is on-site labour only and that travel time, including required down-time between planes to remote communities, will be reimbursed as per government travel policies and stated hourly rates in the pricing proposal. For example, if a service call is required in a community which has only one plane every other day and the problem is resolved on the first day, the contractor can charge labour for the technician's down time waiting for the next plane and for the duration of the flights, as well as the relevant meal, accommodation, and travel expenses. A better example of the service call question below would be a call to a community requiring 8 hours travelling by car. The contractor can charge the mileage. Can the travel time be charged as well?

Answer:

The RCMP will not make any additional allowances for the vendor's travel time.

Question 7:

Also, Gypsumville is included in the list of sites requiring inspection. They will be moving into a new building shortly and a warranty inspection from the supplying contractor will likely be included in the construction contract. For which years will inspections be required under the fire alarm contract? Is the system in the new building addressable?

Answer:

Please include Gypsumville - Building 1 (old) and Building 2 (new, in process of being built). Building 1 will be in the first twenty four months term of the contract and building 2 will included in the last six months of the first 24 month term and any options that are exercised.
