Part 1. Interpretation

- 1.1** Elections Canada hereby amends in accordance with this amendment the Request for Proposal (RFP) bearing number ECLP-RFP-14-0293 and dated July 31, 2014. This amendment hereby forms part of the RFP.
- 1.2** Unless defined herein or unless the context otherwise requires, all of the words and phrases defined in the RFP and used in this amendment shall have the same meanings assigned to them in the RFP.

Part 2. Questions and Answers

The following question(s) have been asked in response to the RFP and Elections Canada hereby answers as follows:

2.1 Question No.5

Question:

Under the item specifications, the color listed under "PRINTING: " and under "INK:" are the same for all items except for EC78791 which notes two different colors. Please confirm if "PRINTING: Prints two colours PMS 2225U Yellow for bag..." and "INK: PMS 120C Yellow for entire outside body of bag..." are correct for this item or if there is a mistake. If so please kindly correct and let us know.

Answer:

The specifications for the item EC78791 are incorrect and should read:

PRINTING: Prints two colours PMS 2225U Cyan for bag – bleeds all sides

Text: Black one side no bleed – front only.

Print quality – Informational

INK: PMS 2225U Cyan for entire outside body of bag – bleeds all sides.

Inside bag to be coated with a grey screen to ensure security of documents.

Black for text.

As such, the Request for Proposal is amended in accordance with Section 3.1 of this amendment.

2.2 Question No.6

Question:

Under an assumption that the specification listed for EC78791 may be copied from

EC50500, or also if it is not:

Under "INK:" this is only listed for items EC78791 and EC50500 that : "Inside bag to be coated with a grey screen to ensure security of documents." And not for the three other items. Please confirm that this specification applies to which of the five items?

Answer:

This specification applies to all of the items and is identified under: STOCK- Co-extruded white outside, grey opaque inside.

Part 3. Amendments

3.1 Amendment to Part B – Mandatory Specifications

Following question 5 of Amendment # 4, the Mandatory Specifications for the **item EC78791** are modified as follows:

Delete the following:

PRINTING: Prints two colours PMS 2225U Yellow for bag – bleeds all sides

Text: Black one side no bleed – front only.

Print quality – Informational

INK: PMS 120C Yellow for entire outside body of bag – bleeds all sides.

Inside bag to be coated with a grey screen to ensure security of documents

Black for text.

Replace with the following:

PRINTING: Prints two colours PMS 2225U Cyan for bag – bleeds all sides

Text: Black one side no bleed – front only.

Print quality – Informational

Insert:

INK: PMS 2225U Cyan for entire outside body of bag – bleeds all sides.

Inside bag to be coated with a grey screen to ensure security of documents.
