The following question is being asked by a potential bidder;

**Q:** I would like to request the weld specifications for Solicitation EB144-150725/A. The provided drawings do not indicate the type of weld that will be required. This information is required to submit an accurate bid.

**A:** The steel plates shown in the detail, Pipe Pile Removals / Repairs on drawing sheet 1 of 2 refer to existing plates which were previously installed on the piles. The structural repair of the piles will be achieved with the reinforced concrete splice installed down the centre of the pile. New steel plates required to reinforce and seal holes in the piles to prevent the release of concrete will be considered for formwork purposes only and it will be the contractor's requirement to determine the welding requirements.
