Question and Answer:

Q1- At the site meeting it was requested that bidders be provided with a listing and number of all devices mentioned in the RFP I.e. Fly Lights, Multi-catch devices, bait stations, etc, however only the number of fly lights and glue boards was included as part of Solicitation Amendment No. 001.

In order to provide a quote for pricing, we do require the number of devices, as this was not specified at the site meeting or as a result of the above mentioned solicitation.

A1- The number of devices other than those provided in Amendment 001 is not available. Bait stations and traps are not part of the monthly inspections and are on an "as and when requested" basis. Estimated usage (# of annual service calls) is provided at Annex E - Calculation of Price for Evaluation Purposes.
